RULING ON SCOPE AND SCHEDULE

(Issued August 26, 2013)

KEVIN J. CASUTTO and DAVID L. PRESTEMON Administrative Law Judges:

On August 13, 2013, Staff Counsel advised us that the parties had agreed upon the scope of issues to be considered in the permanent rates phase of this proceeding, and a proposed schedule for the litigation of those issues. On August 19, 2013, Staff Counsel supplemented the proposed schedule with additional milestones intended to provide for consideration of the applicability of Public Service Law §66(20) to this case. To ensure that all parties had adequate opportunity to raise concerns about the proposals, we notified the parties that we would entertain objections through and including August 21, 2013. None were received.

The proposed scope and schedule, attached hereto as Appendices A and B, respectively, appear reasonable and are unopposed. We will, therefore, adopt them. The parties should be aware, however, that if this case is fully litigated according to the adopted schedule, with a recommended decision and the normal schedule for briefs on exceptions, the earliest possible Commission adoption of an order at a regularly scheduled session would be in August 2014.
