NOTICE SOLICITING COMMENTS AND ANNOUNCING TECHNICAL CONFERENCES

(Issued July 17, 2018)

PLEASE TAKE NOTICE comments are sought on the New York State Energy Storage Roadmap and Department of Public Service (DPS)/ New York State Energy Research and Development Authority (NYSERDA) Staff Recommendations (Roadmap) filed in this case on June 21, 2018. To facilitate review, commenters should organize their comments based on the Roadmap's table of contents headings. For example, a party interested in making recommendations about earnings adjustment mechanisms shall label such comment "4.2.1 Earnings Adjustment Mechanisms."

Interested parties are invited to submit initial comments regarding the Roadmap by September 10, 2018, and reply comments by September 24, 2018. All comments shall be submitted to the Secretary by e-filing through the Department of Public Service's Document and Matter Management System (DMM),¹ or by e-mail to the Secretary at secretary@dps.ny.gov. If unable to file electronically, commenters may make submissions by post or hand delivery to the Hon. Kathleen H. Burgess, Secretary, Three Empire Plaza, Albany, New York 12223-1350.

PLEASE ALSO TAKE NOTICE that DPS Staff, in collaboration with NYSERDA, will convene three technical conferences to solicit stakeholder input and discuss the Roadmap. These technical conferences will be held in New York

City, Long Island, and Albany to facilitate broad stakeholder engagement. Each technical conference will follow the same agenda, consisting of DPS and NYSERDA Staff presentations and opportunities for stakeholders to ask questions. Prior to the technical conferences, Staff will file an agenda and information for participating remotely in the New York State Department of Public Service's Document and Matter Management (DMM) system under case 18-E-0130.

The following topics will be discussed:

- retail rate actions and utility programs;
- utility roles;
- direct procurement;
- market acceleration bridge incentive design;
- addressing soft costs, including barriers in data and finance;
- clean peak actions;
- wholesale market actions, including distribution-level and wholesale-level market coordination;
- and, other Roadmap recommendations.

The July 31, 2018 technical conference will be held from 10:00 a.m. to 4:00 p.m. at the New York State Department of Public Service's New York City Office at 90 Church Street in the 4th floor Boardroom.
