By means of this letter we respectfully request that you commence a proceeding for renewal of the cable television franchise held by Cablevision Industries, Inc. (CVI) pursuant to Section 626 (a)(1) of the Cable Television Consumer Protection and Competition Act of 1992, 47 U.S.C. (The "Act"). Section 626 (a)(1) outlines a proceeding which "...affords the public in the franchise area appropriate notice and participation for the purpose of (A) identifying the future cable-related community needs and interests, and (B) reviewing the performance of the cable operator under the franchise during the then current franchise term."

CABLE TELEVISION FRANCHISE RENEWAL AGREEMENT

TOWN OF DEERPARK

THIS AGREEMENT, executed in triplicate this day of November 20 W, by and between the TOWN OF DEFRPARK, (hereinafter referred to as the Municipality) by the Supervisor acting in accordance with the authority of the duly empowered local governing body, (hereinafter referred to as the Board) and TIME WARNER NY CABLE LLC, a New York General Partnership organized and existing under the laws of the State of New York, the local place of business of which is currently located at 2 Industrial Drive, Middletown, NY 10941 (hereinafter referred to as "Time Warner Cable").

WITNESSETH

WHEREAS, Pursuant to the Town Law, the Board has the exclusive power on behalf of the Municipality to grant franchises providing for or involving the use of Streets (as defined in Section 1 hereof) and to give the consent of the Municipality to any franchisee for or relating to the occupation of the Streets; and

WHEREAS, Pursuant to the Communications Act of 1934, as amended, (the "Communications Act") the Board has the authority to grant cable television franchises and renewals thereof on behalf of the Municipality and whereas the Board and Time Warner Cable pursuant to said Federal Law and pursuant to applicable State laws and the regulations promulgated thereunder, have complied with the franchise procedures required of Municipalities and cable operators in the grant of cable television franchises or their renewal; and

WHEREAS. The Municipality has conducted negotiations with Time Warner Cable and has conducted one or more public hearings on Time Warner Cable's franchise renewal proposal affording all interested parties due process including notice and the opportunity to be heard, said deliberations included consideration and approval of Time Warner Cable's technical ability, financial condation and character; said public hearing also included consideration and approval of Time Warner Cable's plans for constructing and operating the cable television system; and

WHEREAS, Following such public hearing and such further opportunity for review, negotiations and other actions as the Board deemed necessary and that is required by law, the Board decided to renew Time Warner Cable's franchise as provided bereinafter, and

WHEREAS. The Board, in granting this franchise renewal, embedded in this agreement the results of its review and any negotiations with Time Warner Cable and has determined that said tranchise agreement and Time Warner Cable respectively, fulfills and will fidfill the needs of the Manieipality with respect to cable television service and complies with the standards and requirements of the New York State Public Service Commission ("NYSPSC"), LCC, and all other State and Cederal authorities.

NOW, THEREFORE, in consideration of the foregoing clauses, which clauses are hereby made a part of this franchise agreement, and the mutual covenants and agreements herein contained, the parties hereby covenant and agree.

SECTION 1 - DEFINED TERMS

Unless the context clearly indicates that a different meaning is intended:

- a) "Basic Service" means any service tier which includes the retransmission of local broadcast signals.
- b) "Board" means the Town Board of the Town of Deerpark.
- c) "Cable Television Service" means:
 - 1) The one way transmission to Subscribers of Video Programming, or other programming service, and
 - 2) Subscriber interaction, if any, which is required for the selection or use of such Video Programming, or other programming service.
- d) "Cable Television System" means a facility, consisting of a set of closed transmission paths including (without limitation) fiber optic wires or lines, and associated signal generation, reception and control equipment that provides Cable Television Services to multiple subscribers within a community.
- e) "Time Warner Cable" means Time Warner NY Cable LLC.
- 1) "Effective Date" of this Franchise Agreement shall be as provided in Section 4(c).
- g) "Franchise" means the grant or authority given hereunder to Time Warner Cable to construct and operate a Cable Television System in the Municipality in accordance with the terms hereof.
- h) "FCC" means the Federal Communications Commission, its designees and any successor thereto.
- "Gross Revenues" means all revenues derived by Time Warner Cable, either directly or andirectly, from the operation of the Cable Television System to provide Cable Services within the Municipality pursuant to this Franchise, including but not limited to revenues from subscribers for Cable Services; revenues from the carriage of home shopping channels, and sale of advertising. Franchises shall calculate the amount of Gross Revenues in accordance with generally accepted accounting principles ("GAAP"). Revenues from advertising and home shopping eable services shall be allocated to the Municipality based on the number of basic cable subscribers in the Municipality divided by the number of basic cable subscribers who receive the particular advertising or home shopping cable services.
- In "Max" is permissive.

- k) "Municipality" means the Town of Deerpark. Wherever the context shall permit. Board, Council and Municipality shall be used interchangeably and shall have the same meaning under this Franchise.
- Le "NYSPSC" means New York State Public Service Commission.
- m) "Person" means an individual partnership, association, corporation, joint stock company trust, corporation, or organization of any kind.
- n) "Service Tier" means a category of multi-channel Cable Television Service provided by Time Warner Cable over the Cable Television System for which a separate rate is charged for such category by Time Warner Cable.
- or "Shall" or "will" are mandatory.
- p) "Streets" means the surface of, as well as the space above and below, any and all streets, avenues, highways, boulevards, concourses, driveways, bridges, tunnels, parks, parkways, waterways, docks and public grounds and waters within or belonging to the Municipality.
- q) "Subscriber" means any person lawfully receiving any Cable Television Service in the Municipality provided over the Cable Television System.
- r) "Video Programming" means any and all programming services provided by, or generally considered comparable to programming provided by a television broadcast station.

SECTION 2 ~ CONSENT TO FRANCHISE AND CONDITIONS PRECEDENT

a) The Municipality hereby grants to Time Warner Cable the non-exclusive right to construct, erect, operate and maintain a Cable Television System and to provide Cable Television Service within the Municipality as it now exists and may hereafter be changed, and in so doing to use the Streets of the Municipality by erecting, installing, constructing, repairing, replacing, reconstructing, maintaining, and retaining in. on, over, under, upon and across any and all said Streets such facilities (e.g., poles, wires, cables, conductors, ducts, conduits, vaults, pedestals, manholes, amplifiers, appliances, attachments, and other property) as is deemed necessary or useful by Time Warner Cable, for the operation of its cable system. Additionally, the Municipality, insofar as it may have the authority to so grant, hereby authorizes Time Warner Cable to use any and ali ensements dedicated to compatible uses, such as electric, gas, telephone, or other utility transmissions, for the purposes of creeting, installing, constructing, repairing, replacing, reconstructing, maintaining and retaining in, on over, under, upon and across such easoments such facilities of the Cable Television System as is deemed necessary or useful by Time Warner Cable, for the operation of its cable system. Upon request by Time Warner Cable and at Time Warner Cable's sole expense, the Municipality hereby agrees to assist Time Warner Cable in gaining access to such easements

- Nothing in this Franchise shall limit the right of Time Warner Cable to transmit any kind of signal, frequency or provide any type of service now in existence or which may come into existence and which is capable of being lawfully transmitted and distributed by those facilities owned and operated by Time Warner Cable. The provision by Time Warner Cable of any service other than cable service shall be subject to all applicable laws and regulations and to any right the Municipality may have to require fair and reasonable compensation for Time Warner Cable's use of the rights-of-way to provide such service, provided that such requirement is non-discriminatory and competitively neutral.
- e) Without waiver or restriction of the rights available to the parties hereto under applicable law, this Franchise and the attachments hereto constitute the entire agreement between the parties and supersede any and all prior cable television agreements and other agreements or instruments by or between the parties hereto or their predecessors in interest as well as all rights, obligations and liabilities arising thereunder concerning or in any way relating to Cable Television Service.
- d) (i) Time Warner Cable agrees that it will not move, damage, penetrate, replace or interrupt any portion of the Cable Television System of another franchisee without the prior written consent of such other franchisee. Time Warner Cable shall indemnify such other franchisee against any damages or expenses incurred by such other franchisee as a result of any removal, damage, penetration, replacement or interruption of the services of such other franchisee caused by the Time Warner Cable.
- (ii) In the event Grantor grants to any other Person (being referred to as "Other Person" in the below quoted paragraph) a franchise, consent or other right to occupy or use the Streets, or any part thereof, for the construction, operation or maintenance of all or part of a cable television system or any similar system or technology, the Grantor shall include the following language or language to similar effect into any such franchise, consent or other document and/or promptly pass a resolution, conditioning the use of the Streets or any part thereof by any such Person, as follows:

"Other Person agrees that it will not move, damage, penetrate, replace or interrupt any portion of the Cable Television System of another franchisee without the prior written consent of such other franchisee. Other Person shall indemnify such other franchisee against any damages or expenses incurred by such other franchisee as a result of any removal, damage, penetration, replacement or interruption of the services of such other franchisee caused by the Other Person."

- e) Franchisce shall file requests for all necessary operation authorization with the NYSPSC and the LCC within thirty (36) days of the effective late of this Franchise.
- (i) Nothing in this Franchise shall be deemed to walve the requirements of Minnerpol I aw regarding permits (see to be paid to the Minnerpolity for permits or construction, or the master of construction, provided such requirements are consistent with applicable law.

g) As used in this Section, the phrase, "occupancy or use of Streets" or any similar phrase shall not be limited to the physical occupancy or use thereof, but shall include any use above or below the Streets.

SECTION 3 - APPROVAL OF COMPANY BY MUNICIPALITY

- a) This Franchise is subject to and complies with all applicable Federal and State laws and regulations, including, without limitation, the rules of the NYSPSC concerning franchise standards. The Municipality hereby acknowledges and agrees that this Franchise has been entered into by it in accordance with and pursuant to the Communications Act of 1934, as amended, 47 U.S.C. Sec. 521 et seq. The Municipality hereby represents and warrants that this Franchise has been duly entered into in accordance with all applicable local laws. The Municipality herby acknowledges that it, by duly authorized members thereof, has met with Time Warner Cable for the purposes of evaluating Time Warner Cable and negotiating and consummating this Franchise.
- b) Time Warner Cable's technical ability, financial condition and character were considered and approved in a full public proceeding affording due process.
- c) Time Warner Cable's plans for constructing and operating the Cable Television System were considered and found adequate and feasible in a full public proceeding affording due process.
- d) This Franchise is non-exclusive. Any grant of a subsequent franchise shall be on terms and conditions which are not more favorable or less burdensome than those imposed on the Franchisee hereunder.
- e) This Franchise shall not be construed as any limitation upon the right of the Municipality to grant to other person rights, privileges, or authorities similar to the rights, privileges, or authorities berein set forth, the same or other streets or other public ways or public places to the extent permitted under applicable law. The Municipality specifically reserves the right as it deems appropriate, subject, however, to the provisions of Section 3 of the this Franchise. Any such additional franchises and/or other grants of rights to use the streets or other public ways or public spaces shall not adversely impact the authority granted under this Franchise and shall not interfere, except as permitted by applicable law with existing facilities of the Cable Television System.
- f) All rights and privileges granted hereby are subject to the police power of the Municipality to adopt and enforce laws, rules and regulations. Expressly reserved to the Municipality is the right to adopt, in addition to the provisions of this Franchise and existing laws, rules and regulations, such additional laws, rules, and regulations as it may find necessary in the exercise of its police power, provided, however, that such additional laws, rules, and regulations are reasonable, properly within the authority of the Municipality to enact, not materially in conflict with the privileges granted in this Franchise, and consistent with all Federal and State laws, rules, and orders.

- Within thirty (30) days of receipt of formal notification of the Municipality's approval of this Franchise, Franchisee shall file a request for certification of this franchise with the NYSPSC and shall provide the Municipality with evidence of such filing.
- h) The Administrator for the Municipality for this Franchise shall be the Supervisor of the Municipality. The Administrator is responsible for the continuing administration of the franchise on behalf of the Municipality. All correspondence and communications between Time Warner Cable and the Municipality parsuant to this Franchise shall be addressed by Time Warner Cable to the Administrator.
- i) Notwithstanding the foregoing, however, an award or denial of franchise, revocation, termination, or final notice of default shall require a vote of the Municipality's governing body.

SECTION 4 - FRANCHISE TERM

- a) The term of this Franchise shall be ten (10) years from the effective date of this agreement.
- b) A review of this agreement will be conducted by the Municipality after 5 years to ensure that all provisions of this agreement are fulfilled by the parties. Time Warner shall provide any relevant information requested by the Municipality for purposes of this review.
- c) The effective date of this Franchiso shall be the date this agreement is granted a certificate of confirmation by the NYSPSC.

<u>SECTION 5 - ASSIGNMENT OR TRANSFER OF FRANCHISE</u>

- a) Time Warner Cable shall not transfer this Franchise to any person, firm, company, corporation, or any other entity without the prior written consent of the Municipality, which consent shall not be unreasonably withheld or denied.
- b) In the event that the Municipality refuses to grant such consent, it shall set forth specific reasons for its decision in writing by municipal resolution.
- c) Notwithstanding the above, this Section shall not be applicable and no prior approval shall be required if Time Warner Cable shall transfer this Franchise to any of its principal partners, to any parent subsidiary, or affiliate of any of the principal partners of Time Warner Cable, or to any other firms or entities controlling, controlled, by or under the same common control as Time Warner Cable.

SECTION 6 -- REVOCATION, DEFAULT, TERMINATION, ABANDONMENT

- 40 The Municipality may revoke this franchise and all rights afterded to Time Worner Cable becomies in any of the following events or for any of the tollowing toasons.
 - Fime Warner Cable fails, after sixty (60) days written notice from the Municipality, to substantially comply of to take reasonable steps to comply with a

material provision of this Franchise. Notwithstanding the above, should Time Warner Cable comply or take said reasonable steps to comply within said sixty (60) days notice, the Municipality's right to revoke this Franchise shall immediately be extinguished; or

- 2) Time Warner Cable is adjudged bankrupt: or
- 3) Time Warner Cable knowingly and willfully attempts or does practice a material fraud or deceit in its securing of this Franchise; or
- 4) Time Warner Cable practices material fraud or displays repeated negligence in the accurate reporting of information to the Municipality, including, but not limited to information pertaining to Time Warner Cable's calculation of the Municipality's franchise fee: or
- 5) Time Warner Cable fails to pay any legally owed taxes or fees due the Municipality, unless the amount of such payment is part of a good faith dispute or the failure to pay is caused by inadvertent error; or
- 6) Time Warner Cable fails to obtain the prior approval of the Municipality for transfer or assignment of the Franchise pursuant to Section 5 of this agreement; or
- b) Notwithstanding the above, no default, revocation or termination shall be effective unless and until the governing board of the Municipality shall have adopted an ordinance or resolution setting for the cause and reason for the revocation and the effective date thereof. The procedures for adoption of such an ordinance or resolution shall be as follows: Municipality shall provide sixty (60) days prior written notice to Franchisee of a claim of violation and reasons therefore in sufficient detail for Time Warner Cable to address the particulars of the claim; during said sixty (60) day period, Municipality shall cooperate with Time Warner Cable and provide Time Warner Cable an opportunity to cure the alleged violation or provide a cure plan that reasonably satisfies the Municipality. If Time Warner Cable has failed to cure after the expiration of said sixty (60) day period or fails to provide a cure plan that reasonably satisfies the Municipality, the Municipality shall promptly schedule a public hearing no sooner than fourteen (14) days after written notice to Time Warner Cable. Time Warner Cable shall be provided an opportunity to offer evidence and be fully and fairly heard at said public hearing held on the proposed adoption of such ordinance or resolution. Municipality shall obtain and make available to Time Warner Cable, at a reasonable expense to Time Warner Cable, a transcript of said hearing. Time Warner Cable shall have the tight to appeal any such administrative decision to a court of competent jurisdiction as Time Warner Cable may chasse, and revocation of the Franchise shall not become effective until any such appeal has become final or the time for taking such appeal shall have expired.
- or In no event, and notwithstanding any contrary provision in this Section or elsewhere in this Franchise, shall this Franchise be subject to default, revocation, or termination or. Time Warner Cable be liable for non-compliance with or delay in the pectormance of any obligation hareunder, where it's failure to cure or to take reasonable steps to cure is

attributable to formal U.S. declaration of war, government ban on the affected obligation, U.S. government sponsor or supported embargo, civil commotion, strikes or work stoppages, fires and acts of God or nature, or other events beyond the immediate control of Time Warner Cable. In the event of such circumstances as described in this Section, Time Warner Cable shall be automatically excused from its obligations herein during the course of any such events or conditions. Time Warner Cable shall take reasonable measures to notify the Municipality of the existence of circumstances described in this section. The time specified for performance of Time Warner Cable's obligations hereunder shall automatically extend for a time period equal to the period of the existence of the events or conditions and such reasonable time period thereafter as may be necessitated by any such events or conditions.

- d) Time Warner Cable shall not voluntarily abandon any service or portion thereof required to be provided pursuant to the terms of this Franchise without the prior written consent of the Municipality and the NYSPSC. Deletion of or changes to a programming service or functionality of the Cable Television System shall not constitute abandonment of service for purposes of this Franchise.
- e) Upon expiration, termination or revocation of this Franchise without right of renewal, at its sole cost and expense and upon written direction of the Municipality. Time Warner Cable shall remove the cables and appurtenant devices constructed or maintained in the Streets and public rights-of-way in connection with the services authorized herein and provided to subscribers within the Municipality, unless Time Warner Cable, its affiliated entities or assigns should, within six (6) months after such expiration, termination or revocation obtain certification from the FCC to operate an Open Video System or any other Federal or State certification to provide service over the Cable Television System or provided events beyond Time Warner Cable's reasonable control make removal impracticable.

SECTION 7 - INDEMNITY AND INSURANCE

- a) Time Warner Cable shall indemnify and hold harmless the Municipality, its officers, employees, and agents from and against all liability, losses and claims, demands, payments, suits, actions, recoveries and judgments of every nature and description arising from claims of injury to persons or damage to property occasioned by reason of any conduct of Time Warner Cable, its employees or agents undertaken pursuant to this Franchise. The Manicipality shall promptly notify Time Warner Cable of any claim for which it seeks indemnification; afford Time Warner Cable the apportunity to fully control the defense of such claim and any compromise, settlement, resolution or other disposition of such claim, including by making available to Time Warner Cable adrelevant information under its control. Notwithstanding any provision contained herein and to the contrary. Time Warner Cable shall have no obligation to indemnify or defend the Municipality with respect to any programming provided by the Municipality or from the Municipality's negligence.
- by Time Wittner Cable shall, as of the Effective Date of this Franchise, purchase and a dinain commercial general liability insurance that shall include the following adinimum

coverage levels during the term of the this Franchise that will protect Time Warner Cable and the Municipality from any claims against either or both which may arise directly or indirectly as a result of Time Warner Cable's performance hereunder:

- 1) Personal injury or death: \$1,000,000,00 per occurrence.
- 2) Property damage: \$1,000,000,00 per occurrence.
- 3) Excess liability or umbrella coverage: \$10,000,000,00 per occurrence.
- c) Each insurance policy shall bear the name of the Municipality as additional insured. The insurance coverage referred to in this Section may be included in one or more policies covering other risks of Time Warner Cable or any of its parent companies, affiliates, subsidiaries or assigns.
- d) All Time Warner Cable insurance policies and certificates of insurance shall stipulate that the coverage afforded under the policies will not be cancelled until at least thirty (30) days prior written notice has been given to the Municipality. If any policy is cancelled, it shall be replaced forthwith with insurance that meets the requirements of this Franchise so that there is no lapse in coverage.
- e) Upon execution of this Franchise Agreement and within sixty (60) days of written request thereafter. Time Warner Cable shall furnish to the Municipality, certificates of insurance in conformity with the requirements of this franchise, and all other insurance certificates required under Federal and State laws, rules, and regulations.
- f) Time Warner Cable shall obtain all insurance required pursuant to this Franchise from companies authorized to do business within the State of New York and approved by the Superintendent of Insurance, which companies shall maintain a rating of at least Best's A-. The Municipality may, at any time after reasonable notice, review Time Warner Cable's compliance with the provisions of this Section. Should the policies or certificates of insurance provided by Time Warner Cable differ from accepted insurance agency forms, the Municipality shall have the right to review and approve such policies or certificates, provides such approval shall not be unreasonably withheld or delayed.

SECTION 8 - MUNICIPALITY'S RIGHT TO INQUIRE ABOUT AND INSPECT THE CABLE TELEVISION SYSTEM

- (a) The Municipality, at any time, may make reasonable inquiries related to its regulatory responsibilities concerning the operation of the Cable Television System. Time Warner Cable shall respond to such inquiries in a timely fashion.
- b) When repeated subscriber complaints cause the Municipality to question whether the reliability or technical quality of the Cable Television System comply with the requirements of this Franchise, the Municipality shall have the right and authority to require Time Warner Cable to institute a "proof of performance" to reasonably test, analyze, and report on the performance of the Cable Television System consistent with the requirements of NYSPSC Rule 896 (or any subsequently chacted rule telating to

testing and reporting of such tests). Time Warner Cable shall cooperate fully with the Municipality and the NYSPSC in performing such testing. In the event the test shows that Time Warner Cable is not in compliance with the requirements of the Franchise. Time Warner Cable shall bear the costs of the test; if the test shows that Time Warner Cable is in compliance, the Municipality shall be responsible to reimburse Time Warner Cable for the costs of the test.

c) At all reasonable times and for the purpose of enforcement of this Franchise. Time Warner Cable shall permit examination by any duly authorized representative of the Municipality, of all Cable Television System facilities, together with any appurtenant property of Time Warner Cable situated within the Municipality and outside the Municipality if such property is utilized in the operation of the Cable Television System serving the Municipality.

SECTION 9 - MANDATORY RECORD KEEPING

- a) Time Warner Cable shall comply with all record keeping requirements established by Federal and State law, rules, and regulations.
- b) Time Warner Cable shall maintain a full and complete set of plans, records, and "as built" maps showing the exact location of all cable installed or in use in the Municipality, exclusive of subscriber service drops. Municipality specifically recognizes that "as built" maps maintained pursuant to this Section shall be treated as confidential and proprietary, in accordance with the provisions of this Section and applicable law.
- c) All records, logs, and maps maintained pursuant to this Franchise shall be made available to the Municipality or its designee during Time Warner Cable's regular business hours upon reasonable request, subject to the provision of this Section and applicable privacy laws.
- d) Municipality shall treat all materials submitted by Time Warner Cable as confidential and proprietary and shall make them available only to persons who must have access to such information in order to perform their duties on behalf of the Municipality, except:
 - Publicly available information, including materials filed by Time Warner Cable with governmental agencies for which no confidential treatment has been requested;
 - 2) As indicated in writing by Time Warner Cable; or
 - 3) As provided by applicable law.
- e) In the event the Municipality receives request for disclosure of information provided by Time Warner Cable to the Municipality that the Municipality believes in good faith it must provide under law, then the Municipality shall provide Time Warner Cable with written notice of such request as soon as possible prior to disclosure to allow Time Warner Cable to take such measures as it deems appropriate to reduct records submitted

- to the Municipality in an unreducted form and/or to seek judicial or other remedies to protect the confidentiality of such information.
- f) If Time Warner Cable determines in its sole discretion that information requested by the Municipality contains proprietary or confidential date, or if records requested by the Municipality must be kept confidential under applicable law. Time Warner Cable may present reducted version of documents responsive to the Municipality's request.

SECTION 10 - MUNICIPALITY'S RIGHT TO INSPECT TIME WARNER CABLE'S BOOKS AND RECORDS

- a) The Manicipality reserves the right to inspect all books, records, maps, plans, financial statements and other like material of Time Warner Cable pertinent to its compliance with the terms of this Franchise, upon reasonable notice and ruing normal business hours, subject to the provisious of Section 9 of this Franchise.
- b) If any such information is not kept in the Municipality or upon notice Time Warner Cable is unable to provide the records in the Municipality, and if the information is necessary or appropriate to the performance of the Municipality's responsibilities under this Franchise, then all travel and maintenance expenses in excess of fifty (50) miles per day, necessarily incurred in making such examination, shall be paid by Time Warner Cable.

SECTION 11 - REPORTS TO BE FILED WITH THE MUNICIPALITY BY TIME WARNER CABLE

a) Upon request of the Municipality, Time Warner Cable shall make available to the Municipality a copy of any technical, operational, or financial report Time Warner Cable submits to the NYSPSC, the FCC or other governmental entities that concern Time Warner Cable's operation of the Cable Television System under the terms of this Franchise.

SECTION 12 - USE AND INSTALLATION

- a) Time Warner Cable or any person authorized by Time Warner Cable to creet, construct or maintain any of the property of Time Warner Cable used in the transmission or reception of Cable Television Service shall at all times employ due care under the facts and circumstances and shall maintain and install said property of Time Warner Cable in accordance with commonly accepted methods and principles in the cable television industry so as to prevent failures and accidents likely to cause damage or injury to members of the public. All Cable Television System equipment shall conform to those standards of the National Electrical code and the national Board of Fire Underwriters which exists at the time said equipment is installed and replaced.
- h) Time Warner cable agrees to install all Cable Television System equipment in a manner to reasonably minimize interference to be expected with the usual use of the Streets and in no event shall any such Cable Television System equipment be located to as to substantially and regularly interfere with the usual public travel on any Street of the Municipality.

- c) Time Warner Cable shall construct and maintain its cable system using materials of good and durable quality and shall perform all work involved in the construction, installation, maintenance and repair of the cable system in a safe, thorough and reliable manner.
- d) Time Warner Cable shall promptly repair or replace any Municipal property damaged or destroyed by Time Warner Cable so as to restore it to serviceable condition.
- e) Whenever Time Warner Cable, or any person on its behalf, shall cause any injury or damage to public property or Street, by or because of the installation, maintenance or operation of the Cable Television System equipment, such injury or damage shall be remedied as soon as reasonably possible after the earlier of the notice to Time Warner Cable from the Municipality or after Time Warner Cable becomes aware of the same, in such fashion so as to restore the property or Street to serviceable condition. Time Warner Cable is hereby granted the authority to trim trees upon and overhang the Streets of, and abutting private property, in the Municipality to the extent it reasonably deems necessary so as to prevent the branches or growths from coming in contact with the wires, cable and other equipment of the Cable Television System.
- f) If Time Warner Cable disturbs any pavement, sidewalk, driveway or other surfacing. Time Warner Cable shall, at it's own cost and expense in accordance with Municipal law, and within thirty (30) days, replace and restore such pavement, sidewalk, driveway or surfacing so disturbed to as good condition as existed before said work was commenced, to the extent practicable. In the event that any Municipal property is damaged or destroyed by Time Warner Cable, such property shall be repaired or replaced by Time Warner Cable within thirty (30) days and restored to as good condition as existed before said work was commenced, to the extent practicable.

SECTION 13 - USE OF EXISTING POLES AND LOCATION OF UNDERGROUND FACILITIES

- a) Fine Warner Cable hereby agrees that when and wherever it deems it economical and reasonably feasible, it shall enter into agreements with telephone or electrical or other utilities (collectively "utilities") for the use of said utilities' poles or conduit space whereby said utilities shall provide use of and access to said poles or conduit space by Time Warner Cable for Time Warner Cable's lines and other equipment. Notwithstanding the above, where necessary to service subscribers and where attachment to poles or conduit space of utilities is not economically reasonable or otherwise feasible. Time Warner Cable may erect or authorize or permit others to erect any poles or conduit space or any other facilities within the Streets of the Municipality pursuant to the issuance of the Municipality of any necessary authorizations which shall not be unreasonably withheld or delayed. Such crection or poles or conduit space shall be subject to Federal. State, and Municipal laws, rules, and regulations
- b) Subject to the provisions of this Section, in such areas of the Municipality where it or any subdivision thereof shall hereaster only require that all utility fines be installed underground. Time Warner Cable shall install its lines underground in accordance with such requirements.

c) Notwithstanding the foregoing, if Time Warner Cable shall in any instance be unable to install or locate its wires underground, then the Municipality, upon being put on notice of the facts thereof, shall permit such wires to be installed above the ground even though other facilities in the area may be placed, or required to be placed underground. However, any such permission shall be on such conditions as the Municipality may reasonably require.

SECTION 14 - RELOCATION OF PROPERTY

- a) Whenever the Municipality shall require the relocation or reinstallation of any property of Time Warner Cable in or on any of the Streets of the municipality as a result of the relocation or other improvements by the Municipality of any such Streets, it shall be the obligation of Time Warner Cable, on written notice of such requirement, to remove and relocate or reinstall such property as may be reasonably necessary to meet the requirements of the Municipality. In the event any other person, including a public utility, is compensated for similar relocation or reinstallation then in such case Time Warner Cable shall be similarly compensated.
- b) Time Warner Cable shall, on request of a person holding a building or moving permit issued by the Municipality, temporarily raise or lower its wires or other property or relocate the same temporarily so as to permit the moving or erection of buildings. The expenses of any such temporary removal, raising or lowering of wires or other property shall be paid in advance to Time Warner Cable by the person requesting the same. Time Warner Cable shall be given in such cases not less than five (5) business days prior written notice in order to arrange for the changes required.

SECTION 15 - OPERATION AND MAINTENANCE

- a) Fime Warner Cable shall maintain and operate its Cable Television System at all times in compliance with the duly promulgated and lawful provisions of Section 896 of the Rules and Regulations of the NYSPSC and the technical requirements set forth by Section 76 of the FCC Rules and Regulations. Time Warner Cable shall assure that telephone inquiries are handled consistent with FCC standards. Time Warner Cable shall respond to individual requests for repair service no later than the next business day. System outages, and problems associated with channel scrambling and switching equipment, shall be acted upon promptly after notification.
 - In the event a cable outage shall last more than twenty-four (24) hours. Time Warner Cable shall credit the subscriber a pro-rata amount for the length of time service was unavailable.
- by Time Warner Cable shall maintain a means to receive expair service requests and notice of system outages at times when its business office is closed.
- c) Throughout the term of this Franchise. Time Warner Cable's Cable Television System shall have a minimum channel capacity of seventy-eight (78) channels.

SECTION 16 - LINF EXTENSION, FRANCHISE AREA, AND DENSITY

Time Warner Cable shall comply with the requirements for construction of cable television plant and provision of cable television services as set forth in Section 895.5 of the rules of the NYSPSC, provided, however, that Time Warner Cable shall make Cable Services available to residential dwelling units in all areas of the Municipality where the average density is equal to or greater than twenty (20) occupied residential dwelling units per cable mile. Density per cable mile shall be computed by dividing the number of Residential Dwelling Units in the area by the length, in miles or fractions thereof, of the total amount of aerial or underground cable necessary to make service available to the Residential Dwelling Units in such area in accordance with Grantee's system design parameters. The cable length shall be measured from the nearest point of access to the then-existing system, provided that extension is technically feasible from that point of access, and located within the Public Rights-of-Way. The total cable length shall exclude the drop cable necessary to serve individual Subscriber premises.

<u>SECTION 17 - CONTINUOUS SERVICE</u>

- a) Time Warner Cable shall continue to provide cable service to all subscribers who meet their obligations to Time Warner Cable with respect to such service.
- b) Time Warner Cable shall not, without the written consent of the Municipality abandon its Cable Television System or any portion thereof in such a way as would limit its ability to continue to provide cable service to all subscribers.

SECTION 18 - EMPLOYEE IDENTIFICATION/TRAINING

- a) Each employee of Time Warner Cable entering upon private property, including employees of contractors and subcontractors employed by Time Warner Cable, shall have on their person, and shall produce upon request, picture identification that clearly identifies the person as a representative of Time Warner Cable and, notwithstanding any local law, shall display such identification when entering upon private property for the purpose of installing, repairing, soliciting or removing services.
- b) Time Warner Cable shall provide property training for employees and shall institute policies and procedures that foster courteous and professional conduct.
- c) Time Warner Cable will neither refuse to hire or employ, nor bar or discharge from employment, nor discriminate against any person in compensation or in terms, conditions or privileges of employment because of age, race, creed, color, national origin, or sex

SECTION 19 -- RATES

- a) Rates and charges imposed by Time Warner Cable for cable television service shall be subject to the approval of the Municipality, the NYSPSC, and the ECC to the extent required by applicable hederal and State law.
- (a) Time Wurner Cable shall not illegally discriminate against individuals in the establishment and application of rates and charges.

SECTION 20 ~ PUBLIC, EDUCATIONAL, AND GOVERNMENTAL ACCESS

- a) Time Warner Cable shall comply with applicable Federal and State law, rules and regulations pertaining to non-commercial public, educational, and governmental (PFG) access to the Cable Felevision System including Section 895.4 of the rules of the NYSPSC. The PEG channels shall be shared with local governments and residents of other communities served by the system.
- b) Time Warner Cable shall maintain the facilities used to transmit signals from Town Hall at 420 Route 209, Huguenot, NY to its head end for carriage on the PEG channels.
- e) Time Warner Cable has provided a camera (Panasonic PV760 Camcorder Kit # KIVA10055) for PEG programming production use at no cost to the Municipality. Time Warner Cable shall replace the camera with one of similar quality and functionality upon request of the Municipality after the fifth anniversary of the Effective Date or at any time upon request of the Municipality in the event the camera malfunctions by no fault of the Municipality, provided, however, that Time Warner Cable shall not be obligated to provide more than two additional cameras due to such cause.
- d) Time Warner Cable shall provide and maintain a single service outlet and basic service to all school, police station, firehouse and municipally owned building which is occupied for governmental purposes without charge to the Municipality, provided the connection point is no further than two hundred (200) feet from the closest feeder line of the Cable Television System. All such connections shall be above ground except where all utility lines and cables in the area are underground. The Municipality shall not extend such service to additional outlets without the express written consent of Time Warner Cable.

SECTION 21 - MUNICIPAL EMERGENCIES

a) Time Warner Cable shall participate, to the extent required by law, rule or regulation, in the Emergency Alert System established pursuant to Part 11 of the FCC rules. Such facilities shall, to the extent required by law, rule or regulation, be made available to the Municipality on a shared basis with other municipalities in the region.

SECTION 22 - ADDITIONAL SUBSCRIBER SERVICES

- a) Payment for equipment provided by Time Warner Cable to subscribers and the installation, repairs, and removal thereof shall be paid in accordance with Time Warner Cable's standard and customary practices, and applicable rules and regulations of the FCC.
- b) Notice of Time Warner Cable's procedures for reporting and resolving billing disputes and Time Warner Cable's policy and the subscriber's rights in regard to "personally identifiable information" as that term is defined in Section 631 of the Communications. Act, will be given to each subscriber at the time of such person's initial subscription to the Cable Television System services and thereafter to all subscribers as required by Federal et State law.
- Time Warner Cable shall provide notice to each subscriber of its procedures reporting and resolving subscriber complaints as required by applicable regulations.

- d) In accordance with the applicable requirements of Federal and State laws. Time Warner Cable shall provide written notice of any increases in rates or charges for any Cable Felevision Service.
- e) It is agreed that all Cable Television Service offered to any subscribers under this Franchise shall be conditioned upon Time Warner Cable having legal access to any such subscriber's dwelling units or other units wherein such service is provided.
- f) Lime Warner Cable shall comply with the Customer Service Consumer Protection Standards set forth in Sections 890 and 896 of the Rules and Regulations of the NYSPSC.
- g) Time Warner Cable agrees to attend an annual meeting at the written request of the Municipality. This request shall provide at least a thirty (30) day notice of such date as well as provide any specific agenda items.

SECTION 23 -- FRANCHISE FEES

- a) Fime Warner Cable shall pay to the Municipality during the term of this Franchise an annual sum equal to the maximum stated percentage set by law of Time Warner Cable's Gross Revenues as a Franchise Fee provided however that any obligation specified herein shall be consistent with limits on franchise fees established under applicable law. At the time of the effective date of this Franchise, such maximum is five percent (5%).
- b) In the event the law changes and no maximum percentage is set in law, the parties shall negotiate in good faith with respect to such percentage. Until the parties agree on a different percentage, the percentage will be five percent (5%). Such payment shall be made on a quarterly basis for the periods ending March 31, June 30, September 30 and December 31. Each such payment shall be due no later than forty-five (45) days after the close of each such period.
- c) Each quarterly payment shall be accompanied by a report prepared by Time Warner Cable setting out the basis for the computation of the payment.
- d) The Municipality or its agent may question and request data concerning the calculation of scope of the franchise fees paid by Time Warner Cable to the Municipality pursuant to this Section within three hundred sixty five (365) days of their payment. For each such payment, after such three hundred sixty five (365) day period has run, the Municipality shall be deemed to have accepted Time Warner Cable's payment and waived its rights to challenge the amount or calculation of such payment.
- 2) There shall be applied as a credit against the Franchise Lee the aggregate of
 - Any taxes, fees or assessments of general applie willty imposed on Time Warner Cable or any subscribers, or both, which are discriminatory against Time Warner Cable or any subscribers;
 - Any non-capital expenses incurred by Time Warner Cable in support of the PhG access requirements of this Foundhise; and

> 3) Any fees or assessments payable to the NYSPSC which when combined with all other fees and payments deemed a franchise fee under applicable law would exceed the maximum percentage permitted by law of the Gross Receipts.

Time Warner Cable shall have the right to apply franchise fees derived from the operation of the system to provide cable service paid as a credit against special franchise assessments pursuant to Section 626 of the New York State Real Property Tax Law.

SECTION 24 - SEVERABILITY, GOVERNING LAW, POLICE POWERS, REQUESTS FOR AUTHORIZATION AND NON-DISCRIMINATION

- a) Should any provision of this Franchise be held invalid by a court of competent jurisdiction or rendered a nullity by Federal or State legislative or regulatory action, the remaining provisions of this Franchise shall remain in full force and effect.
- b) To the extent not inconsistent with or contrary to applicable federal law, the terms of this Franchise shall be governed and construed in accordance with the laws of the State of New York. The parties hereby acknowledge and agree that any provisions of this Franchise or any existing or future State or local laws or rules that are inconsistent with or contrary to any applicable Federal law, including the Cable Act, as the same may be amended, are and shall be prohibited, preempted and/or superseded to the extent of any inconsistency or conflict with any applicable Federal laws.

SECTION 25 - COMPLIANCE WITH FEDERAL AND STATE LAW

a) Fime Warner Cable shall conform to all Federal and State laws, rules and regulations in the construction and operation of its cable television system. All rules and regulations of the FCC and NYSPSC relating to cable television franchises, as now enacted or subsequently amended, are incorporated herein by reference. Time Warner Cable shall take such additional action as is necessary to formally incorporate in the terms of this franchise any modifications required by amendment of applicable Federal and State laws, rules and regulations governing the contents of cable television franchises within one year of their adoption or at the time of franchise renewal, whichever occurs first.

SECTION 26 - NOTICE

a) All notices required herein shall be in writing and shall be deemed delivered when received by United States certified mail, return receipt requested, or on the date of delivery to addressee when sent by express mail, or overnight, or hand delivered to the parties and locations as specified below. Both Time Warner Cable and the Manicipality may charge where notice is to be given by giving notice to the other.

SECTION 27 - FORCE MAJEURE

In no event, and notwithstanding any contrary provision in this Franchise, shall this Franchise be subject to revocation or termination, or Time Warner Cable be subject to penalty or prejudice or in any way liable for non-compliance with or delay in the performance of any obligations hereunder, where its failure to cure or take reasonable steps to cure is due to reason of strike. Acts of God, acts of public enemies, order of any kind of a government of the United States of America or of the State or any of their departments, agencies, political subdivisions; riots, epidemics, landslides, lightning, earthquakes, fires, hurricanes, tornadoes, volcanic activity, storms, thoods, washouts, droughts, civil disturbances, explosions, partial or entire failure of utilities or any other cause or event not reasonably within the control of Time Warner Cable. Time Warner Cable shall not be deemed to be in violation or default during the continuance of such inability and Time Warner Cable shall be excused from its obligations herein during the course of any such events or conditions and the time specified for performance of Time Warner Cable's obligations hereunder shall automatically extend for a period of time equal to the period of the existence of any such events or conditions and such reasonable thereafter as shall have been necessitated by any such events or conditions.

SECTION 28 - RIGHTS OF ENFORCEMENT

a) Nothing in this Franchise is intended to or shall confer any rights or remedies on any tipled parties to enforce the terms of this i ranchise.

SECTION 29 -- FURTHER ASSURANCES

(a) The Manleipality shall, without further consideration, execute and deliver such turther instruments and documents and do such other acts and things as Time Warner Cable may Tune Wamer Cab Draft May 16, 2011

reasonably request in order to effect and confirm this Franchise and the rights and obligations contemplated herein.

SECTION 30 -- INTEGRATION

- a) This Franchise supersedes all prior negotiations between the parties hereto and shall be binding upon and inure to the benefit of the parties hereto and each of their respective successors in interest and permitted assigns.
- b) This Franchise may be amended (except as otherwise expressly provided for herein) only by agreement in writing signed by duly authorized persons on behalf of both parties. To the extent required by State law, amendments hereto shall be confirmed or approved by the NYSPSC.
- c) This Franchise may be executed in one or more counterparts, all of which taken together shall be deemed one (1) original.
- d) The headings of the various Sections of this Franchise are for convenience only, and shall not control or affect the meaning or construction of any of the provisions of the Franchise.
- c) The rights and remedies of the parties pursuant to this Franchise are cumulative and shall be in addition to and not in derogation of any rights or remedies which the parties may have with respect to the subject matter of this Franchise.

SECTION 31 - NO JOINT VENTURE

a) Nothing herein shall be deemed to create a joint venture or any agency or employment relationship between the parties, and neither party is authorized to nor shall either party act toward any third parties or to the public in any manner which would indicate any such relationship with the other.
