## **NOTICE OF FILINGS** **AND NOTICE OF PUBLIC HEARING**

RE: **Case 10-T-0283** - Joint Petition of Consolidated Edison Company of New York, Inc. and Orange and Rockland Utilities, Inc. Under Section 121 of the PSL to transfer its Certificate of Environmental Compatibility and Public Need

**TAKE NOTICE** that on June 9, 2010, Consolidated Edison Company of New York, Inc. ("Con Edison") and Orange and Rockland Utilities, Inc. ("O&R") filed with the New York State Public Service Commission ("Commission") their Joint Petition for Approval Under Section 121 of the Public Service Law to Transfer Certificate of Environmental Compatibility and Public Need. The Commission's approval of this Joint Petition would allow Orange and Rockland to install a 345 kV circuit (i.e., Transmission Line 28) as an added circuit on the existing transmission towers owned by Con Edison. The attached map indicates the proposed location of Transmission Line 28.

In 1972, the Commission issued a Certificate of Environmental Compatibility and Public Need ("Certificate"), pursuant to Article VII of the Public Service Law, to Con Edison for the construction of up to two circuits on the Southern Tier Interconnection. Pursuant to this Certificate, Con Edison constructed certain transmission towers located between the Ramapo 345 kV Substation and the Rock Tavern 345 kV Substation. Although Con Edison installed Transmission Line 77 on the transmission towers in the 1970s, it has never installed a second circuit in the open position on the transmission towers, as was authorized by the Certificate. Orange and Rockland now wishes to construct, install, operate, and maintain Transmission Line 28 in the open position on these transmission towers.

Con Edison and Orange and Rockland entered into a Lease Agreement, dated April 30, 2008, setting forth the terms and conditions by which Orange and Rockland would lease from Con Edison the open space on the transmission towers and install Transmission Line 28 in the open space. On July 2, 2008, Con Edison and Orange and Rockland filed a Joint Petition with the Commission pursuant to Section 70 of the Public Service Law for approval of the lease arrangement between the companies. A Commission decision on this Section 70 Petition is pending.

Given the time that has passed since the Certificate was granted, Orange and Rockland has prepared an updated Environmental Management and Construction Plan ("EM&CP") for the Transmission Line 28 Project. The EM&CP is attached as an exhibit to the Section 121 Petition.
