

**PETITION FOR A CERTIFICATE  
OF PUBLIC CONVENIENCE AND NECESSITY**

WorldNet IP, Inc. dba Xpress IP ("WorldNet" or "Applicant") hereby petitions the Public Service Commission of the State of New York ("PSC") for the issuance of a Certificate of Public Convenience and Necessity pursuant to Section 99, New York Public Service Law, and Section 21.7 of the Rules and Regulations of the PSC authorizing WorldNet to provide Intrastate / Interexchange telecommunications services as a Common Carrier in the State of New York. In compliance with the provisions of Section 21.7 of the PSC's Rules and Regulations, the following information is provided:

**4. General Description of Services Offered:**

The Applicant supplies long-distance intrastate telecommunications service. Applicant's services and facilities are furnished for communications originating at specified points within the State of New York under the terms of the Intrastate Tariff following in Attachment 12, Exhibit A:

- 4.1 WorldNet installs, operates, and maintains the communications services provided herein in accordance with the terms and conditions set forth under this Tariff. WorldNet may act as the Customer's agent for ordering access connection facilities provided by other carriers or entities when authorized by the Customer to allow connection of a Customer's location to WorldNet's network. The Customer shall be responsible for all charges due for such service arrangement.

WorldNet's services and facilities are provided on a monthly basis unless ordered on a longer-term basis, and are available twenty-four hours per day, seven days per week."

**5. Description of Plant and System to be constructed:**

Current planning includes the installation of collocated switching equipment within the New York City area within a two (2) year period from certification. The New York City site will be used to augment and enhance current switching equipment located at the Primary Business address listed above in paragraph 1.1. No negotiations have been entered into at the current time for a collocation agreement.

The Applicant has no plans to construct facilities within New York or to construct any Interstate facilities opting at the present to lease existing plant and long line facilities from other common carriers, LEC's, and/or CLEC's to fill this need. The Applicant will also utilize current and future technology in order to pass savings on to its customers and maintain profitability in a competitive market.

**6. Slamming and Cramming**

The Applicant has not obtained, and has no intention of obtaining, new customers using either slamming or cramming practices and the Applicant further affirms its adherence and compliance to 16 NYCRR Part 609.

The Applicant affirms its intent that all sales and marketing will be truthful and accompanied with full disclosure and accompanied with third-party verification of consent in order for a new customer to establish service. The Applicant affirms it will notify consumers of any change in their telephone service provider. Further the Applicant affirms that it does not use or condone the use of prize boxes to collect sweepstakes entries together with authorizations to change telephone service providers.

**7. Unauthorized Switching complaints and/or investigation**

The Applicant has no pending, or past, complaints or investigations by either State or Federal agencies of unauthorized switching of a customer's local or long distance.




