Pursuant to 16 NYCRR §96.3(d), 225 East 74th Apartments Corp. ("the Corporation") hereby certifies that it accepts all submetering conditions required by the above-referenced Public Service Commission Order and relevant Commission submetering regulations. Included under these conditions, the Corporation has provided or shall provide the following required notices to the appropriate parties, per the schedule set forth by the Commission.

- The Corporation shall notify current residents individually of submetering not less than two
 months prior to the actual commencement of billing, pursuant to 16 NYCRR §96.3(c)(3). The
 notice shall include the annual HEFPA notice of rights and responsibilities and contact
 information for the NY Department of Public Service Office of Consumer Services. A copy of the
 notice shall be filed with the Secretary.
- The Corporation shall notify prospective and current residents individually through its offering or lease agreement, or through other individual notice, of the consumer protections afforded the residents by HEFPA, and that the Corporation shall provide consumer protections as required by 16 NYCRR §96.6(e).
- The Corporation shall file a meter test plan detailing its annual equipment testing program in accordance with testing procedures and standards outlined in 16 NYCRR Case 17-E-0252-6-Part 92 under Case 11-N-0710, within six months of the date of the Order, that is, by May 22, 2018.

In addition, the Corporation shall adhere to all submetering service conditions, including but not limited to the following:

• File any changes to its plan for HEFPA (16 NYCRR §96.6 (e)) or "Submeter Identification Form" with the Secretary under Case 11-N-0710.

- Deliver submetered electric bills to residents within 30 days of receipt of the Con Edison bill for master-metered service.
- Retain billing records for a period of six years, per 16 NYCRR §96.6(j).
- Not charge residents in excess of the applicable rate cap, per 16 NYCRR §96.6(c).
- Participate in building level demand response or employ an on-site co-generation plant or an alternative, advanced energy efficiency design upon conversion, per requirements of 16 NYCRR §96.5(m).
