CASE 05-S-1376 - Proceeding on Motion of the Commission as to the Rates, Charges, Rules and Regulations of Consolidated Edison Company of New York, Inc. for Steam Service.

ORDER SUSPENDING MAJOR RATE FILING

(Issued and Effective November 22, 2005)

BY THE COMMISSION:

Consolidated Edison Company of New York, Inc. filed with this Commission on November 2, 2005 amendments to its steam tariff schedule which would provide an increase in annual steam revenues of about \$67.6 million or 9.6%, to become effective December 2, 2005. The company's proposal adversely affects the rights and interests of the public and it is in the public interest that hearings be held.

The Commission orders:

1. Without answer or other formal pleading, a proceeding is instituted concerning the propriety of the rates, charges, rules and regulations contained in the amendments to Schedule P.S.C. No. 3 listed in the Appendix.
2. Pending the proceeding and decision on the proposed changes, the operation of these amendments are suspended and the use of the rates, charges, rules and

regulations is deferred through March 31, 2006, unless otherwise ordered by the Commission.

3. The rates, charges, rules and regulations sought to be altered by the suspended amendments shall continue in effect until these proceedings have been disposed of or until the period of suspension and any extension has expired, unless otherwise ordered by the Commission.

4. Consolidated Edison Company of New York, Inc. is directed to file with this Commission, not later than December 1, 2005, a consecutively numbered supplement announcing suspension of the suspended amendments.

5. A hearing in this proceeding shall be held at a time and place to be fixed.
