NOTICE OF PUBLIC STATEMENT HEARINGS ON THE  
CHAMPLAIN HUDSON POWER EXPRESS, INC.  
JOINT PROPOSAL

(CASE 10-T-0139)

The New York State Public Service Commission (Commission) seeks public comment on a February 24, 2012 Joint Proposal (JP), filed in this proceeding. The JP purports to resolve all of the issues raised by the request by Champlain Hudson Power Express, Inc. and CHPE Properties (together, the Applicants) for approval to construct a 1000 MW transmission facility from the international border to New York City (the Facility). While many parties support the proposal, some parties do not.

As outlined in the JP, the proposed Facility will originate underwater at the international border between the United States and Canada and ultimately terminate in Astoria, New York. It will be either underwater or underground for the majority of its length. The Facility's transmission lines will be comprised of two solid dielectric cables, each approximately six inches in diameter. The Facility will deliver 1000 MW of electricity, supplied primarily by new wind and hydroelectric generating sources from Quebec, Canada, to New York City. In addition to the transmission lines, the Facility will also include a converter station and a three-mile long High Voltage Alternating Current (HVAC) cable circuit from the Astoria Annex to the Rainey Substation, located in Astoria New York.

The JP provides for the establishment of a Trust to fund the study and mitigation of any possible impacts that the Facility's underwater cables may have on the habitat in the Hudson, Harlem and East Rivers, Lake Champlain, and their

tributaries. The JP also includes obligations, conditions and requirements that would apply to the construction and operation of the Facility. The Applicants have also requested a water quality certification pursuant to Section 401 of the Clean Water Act (Federal Water Pollution Control Act, 33 U.S.C. § 1341).

The Commission may adopt, adopt with changes, or reject any of the terms of the pending JP. The Commission also may adopt terms other than those proposed.

Members of the public will have an opportunity to present their comments at the public statement hearings before an Administrative Law Judge. Each public statement hearing session will be held open for a minimum of one hour, and will be kept open until everyone wishing to speak has been heard or other reasonable arrangements have been made. It is not necessary to be present at the start of the hearing or to make an appointment in advance in order to speak. Persons interested in speaking will be asked to complete a card requesting time to speak when they arrive at the hearing, and will be called in the order in which the cards are received. Speakers are not required to provide written copies of their comments.

A verbatim transcript of each hearing will be made for inclusion in the record.
