POSTPONEMENT of minor rate filing by Fillmore Gas Company, Inc. to increase its annual gas revenues by about \$300,000 or 27.9%.

SUMMARY OF

RECOMMENDATION: Staff recommends approval of the postponement to August 1, 2013.

On January 29, 2013, Fillmore Gas Company, Inc. (Fillmore or the Company) made a minor rate filing to increase its annual gas revenues by about \$300,000 or 27.9%. The proposed filing has an effective date of June 1, 2013. The Company has agreed to a postponement of the effective date to August 1, 2013 to allow Staff additional time to complete its review.

On April 17, 2013, the Company filed a supplement to implement the postponement and requests waiver of the

requirement of newspaper publication of the change proposed by the supplement.

It is recommended that:

1. Fillmore Gas Company, Inc. be allowed to put Supplement No. 26 to its tariff schedule P.S.C. No. 1 - Gas into effect on May 17, 2013; and
2. special permission be granted waiving the requirement of Section 89-c(10) of the Public Service Law and 16 NYCRR Section 720-8.1 as to newspaper publication of the change proposed by the supplement.
