NYSEG would also continue its Power Partner program for low-income customers, increase economic development funding to \$90 million from \$60 million over the six-year rate period and continue to share earnings above an established level with customers. Over the past four years, this earnings sharing mechanism that is included in NYSEG's current rate plan has provided customers with \$71 million in benefits, and it is expected to provide more than \$100 million in benefits by the end of 2005.

The PSC may approve, modify or reject any or all of the proposed tariff changes. Among other things, the PSC's determination may require revisions of the proposed amount of the increases applicable to particular classifications of service or changes in rates applicable to those classifications for which no increase is proposed by the company. Over the past four years, this earnings sharing mechanism that is included in NYSEG's current rate plan has provided customers with \$71 million in benefits, and it is expected to provide more than \$100 million in benefits by the end of 2005.

The PSC may approve, modify or reject any or all of the proposed tariff changes. Among other things, the PSC's determination may require revisions of the proposed amount of the increases applicable to particular classifications of service or changes in rates applicable to those classifications for which no increase is proposed by the company. 
