These documents are being submitted in further support of the Petition filed in the above-referenced matter. The Form 10 was filed with the SEC and provides greater detail



regarding the corporate reorganization described in the above-referenced Petition and financial information for the entities involved in the corporate reorganization. The NRC supplemental filings set forth the formal names that have been adopted for the entities that are involved in the corporate reorganization. The new corporate entity previously referred to as "NewCo," will be named "Enexus Energy Corporation." The joint venture entity previously referred to as "ENOI Holdings, LLC," will be named "EquaGen LLC". The entity previously referred to as ENO will be named "EquaGen Nuclear LLC." The names of the other companies referenced in the Petition that currently have "Entergy Nuclear" in their names will be revised to be aligned with the "Enexus" name; that is, in each name "Enexus Nuclear" will replace "Entergy Nuclear" (e.g., Entergy Nuclear FitzPatrick, LLC will be renamed Enexus Nuclear FitzPatrick, LLC).
