CASE 18-C-0396 - Joint Petition of T-Mobile USA, Inc. and Sprint Communications Company L.P. Concerning an Indirect Transfer of Control.

NOTICE INVITING COMMENTS

(Issued October 19, 2018)

PLEASE TAKE NOTICE that comments are invited on T-Mobile USA (T-Mobile), Inc. and Sprint Communications Company L.P.'s (Sprint) July 6, 2018 petition seeking approval under Public Service Law (PSL) §100 to transfer certain Sprint telephone systems and assets to T-Mobile. On July 26, 2018, a Supplement was received seeking further approval under PSL §99(2) for a transfer of Sprint's telephone franchise(s). Under the proposed transaction, T-Mobile US, the sole parent of T-Mobile, has entered into an agreement with Sprint Corporation, the parent company of Sprint, pursuant to which Sprint Corporation will become a direct subsidiary of T-Mobile. Following the transaction, Sprint will become an indirect subsidiary of T-Mobile but will not otherwise experience a change of control and will continue to operate as an indirect subsidiary of Sprint Corporation. In the absence of any statutory requirement for an evidentiary hearing, this matter will be reviewed through notice and comment procedures. Comments are due November 16, 2018.
