**Final Minutes – June 2, 2017**

**Administration**

- Review/Modify Agenda: The Draft Agenda was adopted without modification.
- DPS Staff Remarks: None.

**867 HIU/MIU Related Issues**

The BWG Chair discussed an 814C REF\*7G errata workpaper addressing missing NIA and NMA codes. This workpaper will be incorporated into the errata log and the changes to be filed in the 8/31/2017 EDI Report.

Eric Heaton reviewed a workpaper containing 867 HIU/MIU modifications to Con Ed's EDI Supplemental Guidelines document for the 814C, 814E, 814HU, 867HU and 867MU transactions. He then went on to discuss interval ending and beginning times following up upon the discussion from the TWG Chair at the last meeting.

Con Ed plans to implement only electric interval reporting in July; gas interval reporting will come later. Con Ed plans to distribute 867HIU/MIU examples following Phase II testing (internal testing with a single EDI provider). An estimated availability date should be known sometime next week.

Barbara Goubeaud (EC Infosystems) asked if Con Ed could draft some examples to be used in the interim to assist until the above-mentioned examples are available. Dan Stier (Direct Energy) asked if a go-live date had been set. Eric Heaton said that the tentative go live date is July 12<sup>th</sup> but he expects the go live date to be firmed up shortly. Con Ed will notify parties via their ESCO newsletter and a general email. Concern was expressed that the notification would not necessarily reach EDI vendors – an extra effort to contact ESCO EDI vendors would be beneficial. The BWG Chair said the Con Ed newsletter could be posted as workpaper for an upcoming meeting.

Barbara Goubeaud expressed concern that if testing begins June 30 for a July 12 go live date, there will not be enough time for EDI vendor coding purposes.
