Re: Case No. 18-F-0262: Proofs of Service of Notices and Publication for High Bridge Wind LLC's Preliminary Scoping Statement and PSS Notices

Dear Examiners Bergen and Costello,

High Bridge Wind LLC ("High Bridge Wind"), a wholly-owned subsidiary of Calpine Corporation, is proposing to construct a major electric generating facility in the Town of Guilford in Chenango County, New York ("High Bridge Wind Farm Project" or the "Facility"). In order to obtain the Certificate of Environmental Compatibility and Public Need ("Certificate") necessary to construct and operate the Facility, High Bridge Wind filed a Preliminary Scoping Statement ("PSS") on January 24, 2019. Please accept this filing as proof that service of the PSS and related notices was effectuated in accordance with the Siting Board's regulations at 16 NYCRR 1000.5.

Pursuant to Section 1000.5(d) of the Siting Board's rules, High Bridge Wind published notices of the PSS filing in local newspapers the *Evening Sun* (November 16) and in a free local publication, the *Norwich Pennysaver* (November 20). Given that the filing of the PSS was delayed into January 2019, the PSS notices were published again in both publications on December 31, 2018/January 1, 2019, reflecting an updated filing date. Affidavits of publication of this notice are enclosed as *Attachment 1*. Both the original notice and the updated notice of PSS filing were also made available on the Project website (<http://www.calpine.com/highbridgewind>), where they remain for reference purposes.

Pursuant to Section 1000.5(e)(1), at least three days' advance notice of the filing of the PSS was served on each member of the State Legislature in whose district the Facility is proposed to be located. Copies of these letters are attached hereto as *Attachment 2*.

Pursuant to Section 1000.5(e)(3) of the Siting Board's rules, on January 13, 2019, High Bridge Wind provided notice of the impending PSS filing to individuals who have signed up for the Party List on the Siting Board's online docket system for Case 18-F-0262. Proof of that filing, including a copy of the party list at the time of filing, is appended as *Attachment 3*.

On November 16, 2018, High Bridge Wind LLC also mailed a PSS Notice to all members of the Master Stakeholder List, including host and adjacent landowners indicating that the High Bridge Wind PSS would be filed, starting a 21-day comment period on the PSS. This notice and the mailing lists used are appended as *Attachment 4*.

The PSS document was submitted to the Secretary for filing, and served on Parties to this proceeding, via email on January 24, 2019. See *Attachment 5*.

Printed copies of the PSS have been served on the parties identified in 16 NYCRR §1000.5(c). An Affidavit of Service attesting to the electronic service of the PSS is enclosed as *Attachment 6* in compliance with 16 NYCRR §1000.5(f)(a).

High Bridge Wind looks forward to working with the interested parties and stakeholders during the pre-application phase of this process on the scope and content of the Application. Please do not hesitate to contact our office with any questions.

A Thanksgiving Countdown: holiday planning made easier

Thanksgiving is just around the bend, and if you are hosting you might already be thinking about how you might plan things better this year, how to make it all a bit less stressful.

While the truly prepared are already polishing their napkin rings, the rest of us are just starting to wonder, "How can I not want to throw a gray boat out the window?"

Let me start by saying, striving for perfection is overrated. The messiness and imperfection of the holidays is part of what makes each one memorable and particular to your family or the band of friends you share the occasion with.

Still, there are strategies and tricks to making sure Thanksgiving runs smoothly. Here's a game plan for getting things done ahead of time so you can truly enjoy the turkey and pie along with your gang.

ONE WEEK BEFORE

1. Lists, lists, lists: Plan your menu, and make shopping lists, guest lists, lists of who is bringing what, lists of who needs to be picked up when.
2. Create a timeline leading all the way up to the "Dinner is Served" moment. Determine when you are going to get things done (for example, two days before, make Brussels sprouts; one day before, arrange the flowers, etc.). Write down all of the little things, like putting the mashed potatoes into the oven to reheat, filling the ice bucket, setting out the appetizers.
3. Do the Turkey Math: Calculate how long the turkey needs to be in the oven, and remember that it might take up the whole oven for that length of time.

Plan accordingly.

4. Write down who is responsible for what: Giving people a written list of tasks with a time frame makes things clear for them, and lets you hand off things neatly.
5. Buy all non-perishables, including drinks (alcoholic and non), canned and boxed items (broth, cranberries), baking staples (flour, butter, refrigerated pie crusts — what? They are terrific!), and also sturdier produce like potatoes, apples, squash and carrots. Make sure someone is home to help you unload.
6. Give any silver a quick polish (though I firmly believe the slightly tarnished look is in), iron any tablecloths and cloth napkins (though I firmly believe the slightly wrinkled look is in), find those candlesticks and candles.
7. Locate roasting pans, food processor blades, potato ricers, whatever equipment you'll need. Wash whatever hasn't been touched since last year.

ONE TO TWO DAYS BEFORE

1. Back to the market for the turkey, the greens, herbs, flowers and so on. And also all the other stuff you forgot the first time (bay leaves, extra onions, chicken broth).
2. Make as many sides and desserts as possible ahead of time. Brussels sprouts, string bean casserole, mashed potatoes, roasted or pureed squash dishes.
3. Don't be afraid of room

temperature food. Hey, by the time everyone serves themselves and finds a seat, the food isn't going to be super-hot anyway! Give yourself permission to not stress about getting all the food to the table piping hot at the same time. When you go back for seconds, it's always room temperature anyway, right? And has that ever slowed anyone down? Certainly not Cousin Kevin.

3. Set the table, and/or lay out the buffet. Put out all serving platters and serving utensils, and put Post-Its on them so you know what will go in each plate and bowl.
4. Clean, prep and chop any ingredients for the day of.
5. Set up the bar.

THE DAY OF

1. Above all, pay attention to when that turkey needs to go into the oven. We start every Thanksgiving with my mother yelling, "Oh my god, I forgot to put the turkey in! We're going to eat at midnight!"
2. Let people bring things. When Aunt Bunny asks what she can bring, don't say "just bring yourself" — say "cheese." And you can even tell her to bring three different kinds, about ½ pound of each, so that you get what you need. And remind her to bring crackers.
3. Think of tasks to delegate and let people help (otherwise known as, don't be a martyr). So when Uncle Ivan comes into the kitchen looking for a job, you will be able to point him toward the salad for dressing and tussing.
4. Don't be afraid of room

temperature food. Hey, by the time everyone serves themselves and finds a seat, the food isn't going to be super-hot anyway! Give yourself permission to not stress about getting all the food to the table piping hot at the same time. When you go back for seconds, it's always room temperature anyway, right? And has that ever slowed anyone down? Certainly not Cousin Kevin.

THE DAY AFTER

The next day, when you sit down with a bowl of turkey noodle soup and some leftover pinot noir, you can tuck those notes from your super-organized, stress-free Thanksgiving in a folder marked "I Kicked Thanksgiving's Butt," and be that far ahead of the game this time next year.

NOTICE OF SUBMISSION OF PRELIMINARY SCOPING STATEMENT

High Bridge Wind, LLC ("High Bridge" or "Applicant") is proposing to construct a major wind electric generating facility up to 100 Megawatts (MW) in site in the Town of Guilford, Chenango County, New York ("High Bridge Wind Project" or "Facility"). To construct the Facility, the Applicant must obtain a Certificate of Environmental Compatibility and Public Need ("CECPN") from the New York State Board on Electric Generating Siting and the Environment ("Siting Board") pursuant to Article 10 of the Public Service Law and the Siting Board's rules (16 NYCRR Part 1000). This notice announces that on or about November 30, 2018, High Bridge will file a Preliminary Scoping Statement ("PSS"), pursuant to 16 NYCRR 1000.5.

What is the PSS?

The PSS document will describe and identify: (i) the environmental setting in the Facility area proposed; (ii) the potential environmental and community benefits and impacts from construction and operation of the Facility; and (iii) the Facility's anticipated contribution to the State's achievement of its renewable energy generation goals. The PSS will identify and describe the proposed environmental studies the Applicant plans to conduct during the Article 10 process in order to assess potential impacts to land use in the Facility area, public health and safety, ecological resources, protected species and habitats, and water resources; communications; transportation, and utilities; cultural, historical and recreational resources; visual impacts and screening; sound; and impacts on the statewide electrical system.

Furthermore, the PSS will outline potential measures to minimize environmental impacts from the Facility, as well as reasonable alternatives, other required permits/authorizations and other relevant information to be provided in the Article 10 Application.

High Bridge Wind Project

The Facility is proposed to include the installation of up to 30 wind turbines, associated electrical collection lines, access roads, wind management towers, and Operations and Maintenance building. The Facility would interconnect to the New York State power grid at a 115-kV electrical transmission line currently owned by the New York State Electric and Gas Corporation ("NYSEG") in an area northeast of Guilford Lake. High Bridge also proposes to install battery storage. For more information on the proposed Facility, please visit the Siting Board's website under Case 18-F-0262, or the Applicant's dedicated project website (<http://www.calpine.com/highbridgewind>). Hard copies of the PSS containing project details may also be found at the local document repositories listed at the end of this notice.

21-Day Public Comment and Response Periods

The PSS is designed to gather input from the public and interested agencies on the scope and methodology of studies to be conducted in support of a future Application. The PSS filing will start a 21-day period where the public-any person, agency or municipality may comment on the scope and methodology of the studies proposed. Comments on the PSS may be submitted to the Applicant with the Secretary of the Department of Public Service (DPS) at the addresses provided below. The Applicant will prepare a summary of the material comments and its reply to those comments within 21 days after the closing of the comment period. The scoping process is overseen and mediated by a Hearing Examiner who will also schedule a pre-application meeting and provide additional notice for it. The pre-application meeting marks the beginning of stipulation negotiations and allows for the discussion and award of intervenor funding.

Intervenor Funding

To facilitate participation by local municipalities and community groups, High Bridge will provide \$35,000 toward an intervenor fund. Funds will be disbursed by the Hearing Examiners to groups seeking assistance with expenses associated with their participation in the Article 10 process during the pre-application review phase. By law, at least 50 percent of these intervenor funds are reserved for impacted municipalities. Once the PSS is filed, the Hearing Examiners will issue a notice that such intervenor funds are available. The notice will describe the kinds of expenditures which are eligible for receipt of those monies and will provide instructions and a schedule for interested groups to apply for pre-application intervenor funds. Once the formal Article 10 Application is submitted, additional application-phase intervenor funding will be made available to facilitate municipal and party participation in the Application and Hearing phase.

China's Disappeared: A look at who went missing in 2018

BEIJING (AP) — It's not uncommon for individuals who speak out against the government to disappear in China, but the scope of the "disappeared" has expanded since President Xi Jinping came to power in 2013.

Not only dissidents and activists, but also high-level officials, Marxists, foreigners and even a movie star — people who never publicly opposed the ruling Communist Party — have been whisked away by police to unknown destinations.

The widening dragnet throws into stark relief the lengths to which Xi's administration is willing to go to maintain its control and authority.

A look at some of the people who went missing in 2018 at the hands of the Chinese state:

FOREIGN PAWNS
China threatened "grave consequences" if Canada did not release high-tech executive Meng Wanzhou, shortly after the Huawei chief financial officer was detained in Vancouver in December for possible extradition to the U.S.

The apparent consequences materialized within days, when two Canadian men went missing in China. Both turned up in the hands of state security on suspicion of endangering national security, a nebulous category of crimes that has been levied against foreigners in recent years.

Former Canadian diplomat Michael Kovrig was taken by authorities from a Beijing street late in the evening, a person familiar with his case said. He is allowed one consular visit a month and has not been granted access to a lawyer, as is standard for state security cases.

Also detained is Michael Spavor, who organizes tours to North Korea from the border city of Dandong. China has not said whether their detentions are related to Meng's, but a similar scenario unfolded in the past.

A Canadian couple was detained in 2014 on national security grounds shortly after Canada arrested Su Bin, a Chinese man wanted for industrial espionage in the U.S.

Like Spavor, Kevin and Julia Garratt lived in Dandong, where they ran a popular coffee shop for nearly a decade. They also worked with a Christian charity that provided food to North Korean refugees.

While Julia Garratt was released on bail, her husband was held for more than two years before he was deported in September 2016 — about two months after Su pleaded guilty in the U.S.

TAX-EVADING ACTRESS
Fan Bingbing was living the dream. Since a break-

through role of the age of 17, Fan has headlined dozens of movies and TV series, and parlayed her success into modeling, fashion design and other ventures that have made her one of the highest-paid celebrities in the world.

All this made her a potential icon of China's economic success, until authorities reminded Fan — and her legion of admirers — that even she was not untouchable.

For about four months, Fan vanished from public view. Her Weibo social media account, which has more than 63 million followers, fell silent. Her management office in Beijing was vacated. Her birthday on Sept. 16 came and went with only a handful of greetings from entertainment notables.

When she finally resurfaced, it was to apologize. "I sincerely apologize to society, to the friends who love and care for me, to the people, and to the country's tax bureau," Fan said in a letter posted on Weibo on Oct. 3.

She admitted to tax evasion. State news agency Xinhua reported that Fan and the companies she represents had been ordered to pay taxes and penalties totaling 900 million yuan (\$134 million).

"Without the party and the country's great policies, without the people's loving care, there would be no Fan Bingbing," she wrote, a cautionary tale for other Chinese celebrities.

Xinhua commented in a commentary on her case: "Everyone is equal before the law, there are no 'superstars' or 'big shots.' No one can despise the law and hope to be lucky."

SECURITY INSIDER
Unlike most stalked up by China's opaque security apparatus, Meng Hongwei knew exactly who to expect.

Meng, no relation to the Huawei executive, is a vice minister of public security who was also head of Interpol, the France-based organization that facilitates police cooperation across borders.

When he was appointed to the top post, human rights groups expressed concern that China would use Interpol as a tool to rein in political enemies around the world.

Instead, he was captured by the same security forces he represented.

In September, Meng became the latest high-ranking official caught in Xi's banner anti-corruption campaign. The initiative is a major reason for the Chinese leader's broad popularity, but he has been accused of using it to eliminate political rivals.

Xi pledged to confront both high-level "tigers" and low-level "flies" in his crackdown on graft — a promise he has fulfilled by ousting prominent officials.

Meng was missing for weeks, before Chinese authorities said he was

being investigated for taking bribes and other crimes. A Chinese delegation delivered a resignation letter from Meng to Interpol headquarters.

His wife Grace Meng told the AP that she does not believe the charges against her husband. The last message he sent her was an emoji of a knife.

DARING PHOTOGRAPHER

Lu Guang made his mark photographing the everyday lives of HIV patients in central China. They were poor villagers who had contracted the virus after selling their own blood to clear out a living — at a going rate of \$7 a pint, they told Lu.

A former factory worker, Lu traversed China's vast reaches to capture reality at its margins. He explored environmental degradation, industrial pollution and other gritty topics generally avoided by Chinese journalists, who risk punishment if they pursue stories considered to be sensitive or overly critical.

His work won him major accolades such as the World Press Photo prize, but his prominence likely also put him on the government's radar.

This November, Lu was traveling through Xinjiang, the far west region that has deployed a vast security network in the name of fighting terrorism. He was participating in an exchange with other photographers, after which he was to meet a friend in a nearby Sichuan province. He never showed up.

More than a month after he disappeared, his family was notified that he had been arrested in Xinjiang, according to his wife Xu Xiaoli. She declined to elaborate on the nature of the charges.

STUDENT MARXIST

In the past, the political activists jailed in China were primarily those who fought for democracy and an end to one-party rule. They posed a direct ideological threat to the Communist Party.

This year, the party locked in on a surprising new target: young Marxists.

About 50 students and recent graduates of the country's most prestigious universities convened in August in Shenzhen, an electronics manufacturing hub, to rally for factory workers attempting to form a union.

More than was Yue Xin, a 20-something fresh out of Peking University. Earlier this year, she made headlines by calling for the elite school to release the results of its investigation into a decades-old rape case.

This time, she was one of the most vocal leaders of the labor rights group, appearing in photographs with his fist up in a Marxist salute and wearing a T-shirt that said "Unity is strength" — the name of a patriotic Chinese communist song.

Yue, a passionate student of Marx and Mao Zedong, espoused the same values as the party. She wrote an open letter to Xi and the party's central leadership saying all the students wanted was justice for Jiasie Technology laborers.


Her letter quoted Xi's own remarks: "We must adhere to the guiding position of Marxism." Yue called Marx "our mentor" and likened the ideas of

him and Mao to spiritual sustenance.

Nonetheless, she ended up among those rounded up in a raid on the apartment the activists were staying at in Shenzhen. While most have been released, Yue

remains unaccounted for. She has been missing for four months.

High Bridge Wind, LLC (“High Bridge” or “Applicant”) is proposing to construct a major wind electric generating facility up to 100 megawatts (MW) in size in the Town of Guilford, Chenango County, New York (“High Bridge Wind Project” or “Facility”). To construct the Facility, the Applicant must obtain a Certificate of Environmental Compatibility and Public Need from the New York State Board on Electric Generating Siting and the Environment (“Siting Board”) pursuant to Article 10 of the Public Service Law and the Siting Board’s rules (16 NYCRR Part 1000). 
