AMENDED NOTICE OF INFORMATIONAL FORUMS AND PUBLIC STATEMENT HEARINGS

(Issued November 18, 2019)

The Notice of Informational Forums and Public Statement Hearings, issued on November 15, 2019, contained an error. This amended notice is being issued to correct the error and to avoid any confusion.

On January 14, 2019, Canisteo Wind Energy, LLC, (CWE) filed an application for a Certificate of Environmental Compatibility and Public Need (Certificate) pursuant to Public Service Law Article VII for authority to construct and operate a transmission facility consisting of a 34.5/115 kilovolt (kV) collection substation in the Town of Jasper, Steuben County, and a 115 kV electric transmission line of approximately 15 miles in length from the proposed collection substation to the point of interconnection switchyard, where the facility will connect with the New York State Electric and Gas (NYSEG) Bennett Substation on Route 36 in the Town of Hornellsville, Steuben County (the Transmission Project). The Transmission Project would connect the Canisteo Wind Farm, located in the Towns of Cameron, Canisteo, Jasper, Greenwood, Troupsburg and West Union, Steuben County, New York, to the existing NYSEG Bennett Substation. The Canisteo Wind Farm is being reviewed and would have to be approved by the New York State Board on Electric Generation

Siting and the Environment in a separate proceeding (Case 16-F-0205).

At the informational forums, the Department of Public Service Staff will provide an overview of the Article VII certification process for the proposed Project. CWE will then present a brief summary of the proposed Project and will have maps of the proposed project area available for public viewing. Members of the public will then have an opportunity to pose questions about the process and the Article VII application pending before the Public Service Commission.

Those wishing to comment on CWE's proposed Transmission Project will have the opportunity to make a statement on the record at the public statement hearings following the informational sessions. It is not necessary to make an appointment in advance or to present written material in order to speak at the hearings. Persons will be called to speak after completing a request card.

Each public statement hearing will be held open for a minimum of one hour and will be kept open until everyone wishing to speak has been heard or other reasonable arrangements have

been made to include their comments in the record. Reasonable time limits may be set for each speaker as necessary. It is recommended that lengthy comments be submitted in writing and summarized for oral presentation. A verbatim transcript of the hearing will be made for inclusion in the record of this case.
