Dear Secretary Burgess:

I am writing in connection with the Proposed REV Demonstration Projects filed by Niagara Mohawk Power Corporation d/b/a National Grid (“National Grid” or the “Company”) on July 1, 2015 in the subject proceeding pursuant to the Memorandum and Resolution on Demonstration Projects issued by the Commission on December 12, 2014 and the Order Adopting Regulatory Policy Framework and Implementation Plan issued by the Commission on February 26, 2015.

Following a series of discussions with Department of Public Service Staff regarding the proposed work scope of National Grid’s Customer Convenience Demonstration Project, the Company has made substantial revisions to the proposed project. National Grid is hereby filing a revised REV Demonstration Project renamed “Demand Reduction Demonstration Project.” Accordingly, please remove and discard in its entirety the section entitled: Customer Convenience Demonstration Project contained within the aforementioned July 1, 2015 filing (*i.e.*, pages 62 through 86) and replace it with the enclosed Proposed REV Demonstration Projects Revised Scope – Demand Reduction Demonstration Project, marked “(Revised): July 1, 2016.”
