Enclosed are seven (7) hard copies and one (1) searchable electronic copy of Rochester Gas & Electric Corporation's Environmental Management and Construction Plan (EM&CP) and associated drawings for Segment II of the Rochester Area Reliability Project (RARP). Segment II includes the relocation of a portion of Circuit 906 and the construction of portions of Circuits 940 and 941. Segment III of the EM&CP will be submitted after the Commission reaches a final decision on the location of Station 255.

The EM&CP consists of a document and associated drawings, and details the location of the facilities, the manner in which they will be constructed, and the environmental protection measures that will be implemented during construction. The hard copies and the electronic copy of the EM&CP contain copies of the actual notices served on the parties identified on the attached service list.

Copies of the EM&CP are being served upon the staff of the Department of Environmental Conservation at the Albany and regional offices; staff of the Department of Agriculture and Markets; the Commissioner of the OPRHP; and the Department of Transportation. Parties on the Public Service Commission's Party List for this proceeding, statutory parties not receiving the full EM&CP, persons from whom property rights will be needed for the RARP, and owners of property adjacent to the sites where construction work will be performed are being notified of the filing of the document. In addition, a notice of filing will be published in a newspaper of general circulation in the vicinity of the project. Copies of the notice of filing to be published and of the forms of notification letter are included in the EM&CP.
