Dear President Pro Tem Flanagan:

This is to inform you that Atlantic Wind LLC (“the Applicant”), a wholly-owned subsidiary of Avangrid Renewables, LLC (AR) has submitted a Preliminary Scoping Statement to the New York State Board on Electric Generation Siting and the Environment (Siting Board) regarding its proposal to develop its 100 megawatt (MW) wind powered electric generating project located within the Pinckney, Harrisburg, and Montague, in Lewis County, New York. The proposed Point of Interconnection is located in the Town of Rodman in Jefferson County, New York. The filing triggers the need to appoint ad hoc public members to the Siting Board to participate in the review of the proposed facility.

Pursuant to Article 10 of the Public Service Law, in your capacity as President Pro Tem of the Senate, you should be receiving nominations of four candidates each for ad hoc public members from the Towns of Pinckney, Harrisburg, Montague, Rodman, and Lewis and Jefferson Counties. You have 30 days from receipt of the list of nominated candidates to appoint one ad hoc member from the list of candidates. If you do not make an appointment within 30 days, the Governor shall appoint the ad hoc member from the list of nominated candidates. If an ad hoc member has not been appointed within 45 days, a majority of persons named to the Siting Board shall constitute a quorum.
