- (e) general partnership interests of LNG Marketing Partners, a Connecticut general partnership, representing 10% of its outstanding general partnership interests;
- (f) general partnership interests of LNG Storage Partners, a Connecticut general partnership, representing 20.0857% of its outstanding general partnership interests

On November 19, 2013, IUSA's capital increased by \$7,271,000,000 through the issuance of 143 new shares of IUSA common stock to Iberdrola UK Finance Limited ("IBFL") in consideration for 6,785.644 shares of common stock of Iberdrola Renewables Holdings, Inc., ("IRHI") (representing all of the outstanding capital stock of IRHI).
