To parties:

Pursuant to our October 22 ruling, statements in support or opposition of the JP are due December 21, and the evidentiary hearing is scheduled for January 7.

Our intention is to send out a set of ALJ questions by the end of the day tomorrow (Wednesday the 12th). These questions should be addressed, if possible, in Statements of Support. If responses to any particular questions aren't ready by December 21, the Statements should indicate what date (in advance of the hearing) a response will be provided.

We might have more questions in addition to the ones we send tomorrow, and we might have follow-ups after December 21.
