# Central Hudson:

## Electric:

All service classification 1 & 6 customers are residential. The non-demand rates are not able to be determined by service classification. Rate code E230 and E235 are considered non demand rates and are part of service classification 2.

## Gas:

All customers in service classification 1 and 12 are residential. There is no way to determine by rate code which accounts meet the 750 DTH. They will be part of service classification 2. ## **Definition of Mass Market Customer**

Pursuant to the Commission's <u>Order Resetting Retail Energy Markets and Establishing Further</u> <u>Process</u>, issued and effective February 23, 2016, in Cases 15-M-0127, 12-M-0476, and 98-M-1343, we are providing criteria as to how to identify mass market customers. Below is a list of Gas and Electric Service Classes identified by residential or small commercial.

Residential Electric: SC = 1, 7, 16, 18, 21, 27, 41, 70, 72, 73, 75, 116, 118, 901, 907, 921 or 941

Religious Electric SC: SC = 37, 42, 51 or 71

Electric Small Commercial SC SC = 2, 6, 22, 26, 28, 30, 31, 117, 330 or 331

Residential Gas:

Please note that Electric small commercial customers may still have demand meters. These customers are not considered Mass Market. You may determine this through the RAIS website, or by reviewing the meter information in the EDI Files 867HU, 867MU or 814E. Non-demand billed customers will not have any kW readings in EDI or RAIS.

Please note that Gas small commercial customers have a threshold of 750 dekatherms per year. For customers with multiple meters, this threshold shall be calculated using the sum of all meters in the customer's name within a utility service territory. You may determine if a customer meets this threshold by utilizing the 867HU EDI file and evaluating the customer's usage. Con Edison does not have a method to identify these customers.

## **Gas Service Class Information**

On February 23, 2016, the Commission issued an Order<sup>1</sup> changing the conditions under which residential and small non-residential customers are served in New York. National Fuel Gas Distribution Corporation ("National Fuel") is providing criteria as to how to identify mass market customers. Below is a list of Gas Service Classes provided through EDI transactions (REF~NH) used to identify customer accounts as residential:

1, 2, 5, 21, 42, 50, 55-57, 64, 65, 70-79

The Gas Service Classes listed below are non-residential and may contain customers with consumption less than 750 Dth per year potentially qualifying them as mass market customers:

3, 6, 23, 46, 50<sup>2</sup>

For these Gas Service Classes, ESCOs should obtain account usage information to make their determination whether the customer should be classified as a mass market customer or not.

National Fuel accounts assigned to other Gas Service Classes not listed above have consumption excess of 750 Dth per year.
