The August 2014 EM&CP Supplement responds to further comments received from the Department of Public Service Advisory Staff and the NYS Department of Agriculture & Markets after the submission of the May 2014 EM&CP Supplement in this case, and amends portions of the EM&CP, as appropriate. In light of the selection of the project by the Commission in the Indian Point Proceeding and the expected in-service date of June 2016, we ask that the Commission conduct an expedited review of the August 2014 EM&CP Supplement.
