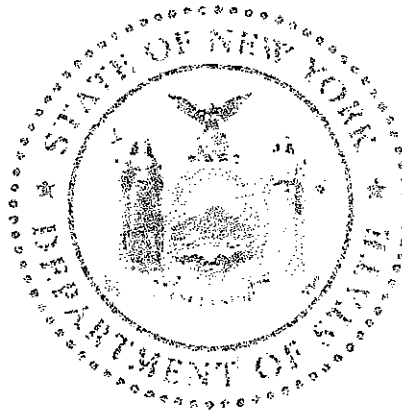

**FIRST:** The name of the Company is:


