On July 2, 2015, Charter Communications, Inc. ("Charter") and Time Warner Cable Inc. ("TWC") (together, the "Parties") jointly filed the above-referenced petition. On January 8, 2016, the Commission granted that petition subject to conditions.

Charter hereby notifies the Commission that, on May 18, 2016, the transactions approved in the Commission's January 8, 2016 order were consummated and Charter (reorganized into "New Charter" as set forth in the Parties' joint petition) is now the ultimate indirect parent of Time Warner Cable Information Systems (New York), LLC ("TWCIS"), Time Warner Cable Business LLC ("TWCB"), Time Warner Cable Northeast LLC, and Time Warner Cable New York City LLC, as well as the continued owner of Charter Communications Entertainment I, LLC ("CCE-I") and Charter Fiberlink NY-CCO, LLC ("Charter Fiberlink").

Diagram of Organization Structure Prior to Transactions¹




Diagram of Organization Structure Following Transactions¹
