Subject: **Case 10-T-0080** - construction of a new single circuit 115 kV transmission line, approximately 33 miles long, that will be located primarily within an existing National Grid right-of-way from the Spier Falls Substation in the Town of Moreau to the Rotterdam Substation in the Town of Rotterdam along Saratoga and Schenectady Counties, and certain other associated activities.

On or about April 13, 2012, Niagara Mohawk Power Corporation d/b/a National Grid (“National Grid” or the “Company”) filed the second and third phases (“Phase II EM&CP” and “Phase III EM&CP,” respectively) of three phases of a proposed Environmental Management and Construction Plan (“EM&CP”) with the New York Public Service Commission (“Commission”) pursuant to the Order Granting Approval of Environmental Management and Construction Plan, issued and effective September 16, 2011 (“Phase I EM&CP Approval Order”) and in compliance with the Order Granting Certificate of Environmental Compatibility and Public Need, issued and effective February 24, 2011 in Case 10-T-0080 (“Certificate Order”). (In the Phase I EM&CP Approval Order, the Commission approved the first phase (“Phase I EM&CP”) of the EM&CP, which the Company filed with the Commission on April 29, 2011 and supplemented and revised on July 22, 2011.)

**EM&CP**

The project proposed in the EM&CP (the “Project”) is comprised of the following three components: (i) construction of a new single circuit 115kV transmission line; (ii) busing together the Company’s existing Spier Falls to Rotterdam Lines 1 and 2; and (iii) rebuilding and reconductoring 4.2 miles of the Company’s existing Ballston Tap Line 2. Generally, the Project will extend approximately 33 miles from the Spier Falls Substation in Saratoga County to the Rotterdam Substation in Schenectady, New York.

**EM&CP Phases**

The Phase II EM&CP addresses the section of the Project adjacent to Moreau Lake State Park (including the Project’s transmission line Structure No. 21) with details such as completed landowner easement agreement information, tower foundation design, and access road and grading plan. The Phase III EM&CP contains a proposed Comprehensive Wetland Mitigation Plan. National Grid previously developed a proposed Wetland Mitigation Plan, dated July 2011 (the “Mitigation Plan”), and included it as part of the Phase I EM&CP. The Mitigation Plan described the wetland impacts associated with the Project, identified the Project’s wetland mitigation goals and objectives, and identified the components of the Proposed Comprehensive Wetland Mitigation Plan to be submitted to the U.S. Army Corps of Engineers (“USACE”), the New York State Department of Environmental Conservation (“NYSDEC”), and the New York State Department of Public Service (“NYS DPS”). Niagara Mohawk Power Corporation d/b/a National Grid (“National Grid”) is planning to construct a new 115 kV electric transmission line and to bus together certain existing lines between its Spier Falls substation in Moreau, NY and its Rotterdam substation in Rotterdam, NY, as well as to rebuild and reconductor a portion of its existing Ballston tap line (the “Project”). This Project is under review by the New York Public Service Commission (“Commission”) in Case 10-T-0080. As part of the review process, National Grid recently filed with the Commission the second and third phases of three phases of an Environmental Management and Construction Plan (“EM&CP”) for the Project. (National Grid filed the first phase with the Commission on April 29, 2011.) Enclosed you will find a copy of National Grid’s Notice of Filing of the second and third phases of the EM&CP for the Project.

In its February 24, 2011 Order (“Order”) in Case 10-T-0080, the Commission directed National Grid to provide notice of these EM&CP filings to property owners from whom it will acquire property rights in connection with the Project. You are one such property owner. Accordingly, pursuant to Ordering Clause 26(a)(iii) of the Order, please be advised that, with respect to the above-referenced property, the following property rights are to be (or have already been) acquired by National Grid for the Project:

An easement on an approximately 20 foot wide corridor of your property where it abuts the National Grid electric transmission right-of-way, delineated on the Plan and Profile drawings in the Project’s Environmental Management and Construction Plan as the “additional vegetation management area boundary line.” This easement encompasses (a) permanent vegetation management rights, (b) temporary rights for all construction-related activities, (c) permanent rights for operation and maintenance of the Project during and after construction, and (d) permanent rights for environmental mitigation and protection.

A temporary Access Road easement on your property. This easement will entitle National Grid and its contractors to obtain access to the right-of-way.
