Re: Case 12-T-0248 - Application of New York State Electric & Gas Corporation for a Certificate of Environmental Compatibility and Public Need for Construction of the "Columbia County Transmission Project," Approximately 11.1 Miles of 115 Kilovolt Transmission Lines and related facilities in the Towns of Chatham, Ghent, and Stockport, in Columbia County

Dear Secretary Brillig:

By letter of June 22, 2012, you notified New York State Electric & Gas Corporation ("NYSEG") that certain deficiencies had been identified in its application for a certificate of environmental compatibility and public need under Article VII of the Public Service Law for the Columbia County Transmission Project, and also directed NYSEG to file additional information that, while not required for NYSEG's application to be in compliance with Public Service Law Section 122, should be provided so that the review process for the application could be expedited.

As attorney for NYSEG, I am enclosing for filing with the New York State Public Service Commission ("Commission") seven paper copies and nine electronic copies of NYSEG's responses to all of the deficiency items except Item 5 and to all of the Requests for Additional Information except Requests E, J, and L. The electronic copies of the textual material are provided on a CD, the maps and similar materials are provided on a separate CD, and the requested GIS shapefile is being provided on a DVD. The responses to deficiency item 5 and to additional information items E, J and L have not yet been completed. NYSEG anticipates filing the remaining responses before December 16, 2012. The majority of the responses are being filed now to allow Department of Public Service Staff to commence review of the materials sooner while the remaining items are being completed.

By Order on Waiver Requests issued September 14, 2012 in this proceeding, the Commission granted in part NYSEG's request for waivers of certain of the Commission's Article VII regulations, and directed NYSEG to file additional information relating to certain of the NYSEG's other waiver requests.

The information responsive to that direction is included in the enclosed filing. Specifically, with respect to the request for waiver of the requirements of 16 NYCRR §86.3(a)(1), NYSEG has provided 2010 edition USGS quadrangles, as outlined in the response to deficiency item 12 and as included in Attachment 2, Attachment 12a, Attachment B and Attachment F. With respect to the request for waiver of the requirements of 16 NYCRR §86.4(a)(4), NYSEG has provided in Response 12 a statement on its correspondence with the New York Independent System Operator on the need for a System Impact Study and has provided that correspondence in Attachment 12c. With respect to NYSEG's request for waiver of the requirements of 16 NYCRR §86.3(b)(1)(iii), NYSEG has provided the identification of access roads required by the Commission's Order in Response 12 and on a map in Attachment 12b.

Finally, I am enclosing a revised copy of Exhibit 1 to the Application. The only change in this Exhibit is the telephone number for the Applicant.

NYSEG is serving copies of the enclosed materials on all parties that received the original Application and on all other persons on the Commission's Party List for this proceeding at the addresses indicated on the attached service list.
