Dear Commissioner Rhodes:

I am writing to warn you of the dangerous consequences of approving the joint application to transfer the Indian Point license from Entergy to Holtec. As you may be aware, Holtec and its affiliated Limited Liability Corporations have an established track record of bribery. What's more, Holtec is reported to be the subject of a criminal investigation in New Jersey.

What you may not know is the extent of Holtec's efforts to limit its liability with shell companies.

The second page of this letter documents more than 30 separate Holtec corporations in Delaware, Florida, and New Jersey. The purpose of these entities is to prevent financial losses to the owner, Krishna Singh.

An accident or terror attack at Indian Point could affect the health of millions. In the case of Fukushima, TEPCO, claimed the disaster site to be *bona vacantia*, a legal term meaning "an ownerless property for whom no one is responsible."

That's exactly what Entergy is doing to New York State now:

Entergy is transferring ownership of nuclear waste with *nuclear weapons potential* to a private shell corporation for whom no one is responsible. Don't do it.
