NOTICE INVITING PUBLIC COMMENT ON  
WHITE PAPER ON RATEMAKING AND UTILITY BUSINESS MODELS

(Issued July 28, 2015)

PLEASE TAKE NOTICE that the New York State Public Service Commission (Commission) invites comment on the "White Paper on Ratemaking and Utility Business Models" (Ratemaking White Paper) filed by the New York State Department of Public Service Staff on July 28, 2015 in the Reforming the Energy Vision (REV) proceeding. The Ratemaking White Paper recommends comprehensive reforms of ratemaking practices in furtherance of the Commission's vision for the future of the electric industry as contemplated in REV.

The document may also be viewed by entering the Case number 14-M-0101 from the Search function on the Department's website ([www.dps.ny.gov](http://www.dps.ny.gov)). Although comments are invited on all aspects of the Ratemaking White Paper, in particular the Commission asks parties to follow the format for comments recommended in Part V of that document.

Parties may file initial comments by October 5, 2015 and reply comments by November 1, 2015. All comments will become part of the record considered by the Commission. Written comments will be posted for public viewing on the Commission's website. There are several ways to provide your comments to the Commission:

Via the Internet or Mail: The public may submit comments directly into the case file by locating the case via
