**Project Description**

Article 10 of the Public Service Law provides the regulatory process for siting some power plants in New York State. Astoria Generating Company, L.P. ("AGC") operates two generating stations on barges in the East River along the shore of the Gowanus/Sunset Park neighborhoods, Community District 7, Borough of Brooklyn, Kings County, City of New York, namely the existing Gowanus Generating Station ("Gowanus") and Narrows Generating Station ("Narrows"). AGC is proposing under Article 10 to repower the older, less efficient electric generating units at Gowanus and replace them with new, more efficient electric generating units (the "Gowanus Repowering Project" or the "Project"). The Gowanus Repowering Project will entail the replacement of the current 32 older generating units on four barges with eight larger more efficient, natural gas-powered units situated equally on two barges. The current megawatt ("MW") rating of Gowanus is 640 MW. The Project will result in a MW rating no greater than 610 MW, 30 MW less than the current facility. The current MW rating of Narrows is 320 MW. Upon the commencement of operation of the Project, AGC will retire Narrows resulting in a total decrease of 350 MW of traditional generation in the area. AGC believes the Project sizing with the retirement of Narrows will result in cleaner, more efficient electric generation and provide the electric reliability required for the Gowanus/Sunset Park neighborhood as renewable energy production expands over time. Furthermore, the Project, by continuing the location of the generating units on barges, will also maintain the critical infrastructure resilience demonstrated by the existing Gowanus facility. The public information meeting will provide information about the project and the Article 10 review process and will provide an opportunity for the public to ask questions.



# 男女被起訴涉嫌虐4幼兒 2人因狗籠全部營養不良



本報訊

德州一對年輕男女涉嫌虐待4名子女，被當局控以多項罪名。警方指，案中4名孩子全部營養不良，其中2人更被困在狗籠內，是警方多年來見過「最嚴重」的虐兒案。

綜合NBC、霍士新聞及heavy.com網站報道，德州北部懷斯縣(Wise County)警方12日早上7時許接報，指沃斯堡(Fort Worth)西北25哩外的羅馬(Rhome)社區發生家庭糾紛案，警員到場後發現24歲男子法比拉(Joseph Fabila)臉部有多處傷痕，相信是他的24歲女伴哈金斯(Paige Harkings)造成，正當警員與兩人談話時，屋外類似倉庫的臨時建築物傳出聲音，警員檢查後赫然發現當中藏著4名孩子。

懷斯縣副警長約翰遜並形容，4名孩子年齡分別為1歲、3歲、4歲、5歲，當時所處的環境「骯髒雜亂」，

其中5歲男童和4歲女童，更被困在3呎見方的狗籠內，另外2名較年幼的孩子，衣不蔽體，所有人身上沾滿便溺，明顯疏於照顧。縣警長艾金(Lane Akin)也說，4名孩子當時又渴又餓，倉庫內雖有充足食物，但冰箱卻放在孩子接觸不到的地方，冰箱門並貼上封條，櫥櫃也上了鎖，使得孩子根本無法取食。

警方形容，案件性質「不可接受」，4名孩子相信由於營養不良，發育也受到影響，體型相信小於同齡兒童。事後當局已把孩子送往沃斯堡的兒科醫院檢查，然後經兒童福利部門轉送寄養家庭。

至於法比拉與哈金斯兩人，各自被控4項危害兒童罪名，哈金斯由於涉嫌毆打法比拉，再被加控1項嚴重傷人罪，法比拉一度往醫院檢查，其後與哈金斯共同入獄候審。消息指，案中4名孩子均是哈金斯所生，但法比拉只是其中1人的父親。鄰居

表示，法比拉與哈金斯兩人幾星期前才搬到涉案地址，之前並不知道他們有孩子。州府兒童福利部門則說，之前在另一個地址也曾接觸兩人。諷刺的是，媒體發現哈金斯的臉書頁面留有多張孩子照片，相中孩子似乎生活正常，哈金斯更留言稱「我愛孩子」。

## 歌手21 Savage遭拘留9日 獲准保釋仍可能被遞解

饒舌歌手21 Savage涉嫌非法居留，遭移民及海關執法局(ICE)拘留9日後有望暫時重獲自由。其律師公布，當局已批准21 Savage保釋外出。

綜合全國公共廣播電台(NPR)、CBS及TMZ報道，21 Savage的律師團隊指出，21 Savage 12日辦理保釋手續後，13日可離開拘留中心。目前他正等候接受移民法庭審訊，意味仍有可能被遞解出境。這位饒舌歌手在拘留期間，錯過10日晚上舉行的格萊美頒獎禮(Grammy Awards)，他透過律師團隊表示他用心體會這場樂壇盛事，並感謝歌迷及各界

支持。他又稱，比以往更珍惜與親人相聚，希望能繼續製作音樂。

現年26歲的21 Savage原名阿伯拉罕-約瑟夫(Shayaabin Abraham-Joseph)出生於英國，2005年7月合法來美的時候仍未成年，其後未有根據非移民簽證條款離境，簽證已在2006年7月到期，現時在美屬於非法居留。此外，21 Savage還涉及2014年一宗毒品案。21 Savage 3日在亞特蘭大觀看超級碗賽事時，遭執法人員拘捕。據報，他正申請U簽證繼續留美。U簽證是一種特殊簽證，專為暴力或其它刑事罪行的受害人而設，倘若非法移民

協助執法部門調查，便可受到保護並合法居留。有移民律師表示，太多非法移民申請U簽證，導致名額供不應求，預料21 Savage可能要輪候10年。

非裔權益組織「Black Lives Matter」聯同民權組織「Color of Change」等12日到亞特蘭大移民法庭外抗議，並向ICE遞交有45萬人簽署的請願信，聲援21 Savage留在美國。由於ICE職員拒絕接收請願信，示威人士改為放置於法院門外。有研究顯示，每日有成千上萬無證移民被ICE拘留，不過大多數被捕人士未如21 Savage般幸運，一般都不准保釋外出。 本報訊

加州新任州長紐森(Gavin Newsom)以「成本太高、工程耗時太長」為理由，取消來往洛杉磯和三藩市灣區之間的高速鐵路工程。對於紐森宣布放棄來往洛杉磯和三藩市灣區之間的高鐵工程，運輸部長趙小蘭的發言人，拒絕評論有關消息。

綜合《華盛頓觀察家報》和路透社報道，紐森12日發表上任以來首份州長咨文演說，內容包括同屬民主黨的前州長布朗(Jerry Brown)支持的高鐵項目。紐森形容，來往洛杉磯和三藩市灣區的高鐵「成本太高，工程也會花太長時間，項目監管太少，透明度不夠」，因此決定取消有關工程。

紐森取消的高鐵項目早於2008年投票通過，但首階段最新成本估算高達770億元，遠高於當初預計的大約48%，完工日期也要推遲到2033年。另外，現時來往兩地的航班只需大約1小時，但高鐵行車時間需要4小時，車票也可能較機票昂貴。即便點到點開車，車程也只需大約6小時。

紐森認為，加州沒有方法興建一條由沙加緬度(Sacramento)前往聖地牙哥(San Diego)的高鐵，但強調現正興建、連接貝克斯菲爾德(Bakersfield)和默塞德(Merced)的高鐵會繼續進行。這條高鐵路段長約120哩，跨越加州主要農業區，紐森相信興建高鐵有助帶來經濟轉型。

州府去年3月曾經預計，這路段預估成本已經由770億元大增130億元，警告最後成本可能超過980億元。紐森表示將會繼續尋求撥款完成工程。

前總統奧巴馬2010年承諾撥款35億元，支持有關工程項目，加州選民也曾在2008年同意發債100億元資助興建。運輸部監察長去年8月估計，加州政府只能確保項目具備約300億元資金，不及建築成本的一半。

項目簡介

《公共服務法》第 10 條規定了紐約州一些發電廠選址的監管程序。Astoria Generating Company, LP ( 簡稱 AGC ) 在紐約市金斯郡布魯克林第 7 區 Gowanus / Sunset Park 社區的東河沿岸駁船上運行有兩個發電站，即現有的 Gowanus 發電站 ( “Gowanus” ) 和 Narrows 發電站 ( “Narrows” ) 。AGC 根據第 10 條提議重新改造 Gowanus 老舊低效的發電機組，並用新式且高效的發電機組 ( “Gowanus 改造工程” 或 “工程” ) 來取而代之。Gowanus 改造項目將需要平均分布在兩艘駁船上的 8 個更大、更高效的天然氣發電機組替換 4 艘駁船上現有的 32 個舊發電機組。目前 Gowanus 的兆瓦 ( “MW” ) 等級為 640MW。該項目將使其 MW 等級不超過 610 MW，比現有設施低 30 MW。Narrows 目前的 MW 等級為 320MW。在項目投產後，AGC 將淘汰 Narrows 發電站，從而導致該地區傳統發電量減少 350MW。AGC 認為，隨著可再生能源產量的不斷擴大和 Narrows 的退役，該項目規模將帶來更清潔，更高效的發電，並為 Gowanus / Sunset Park 社區提供所需的電力可靠性。此外，通過保留駁船上的原發電機組定位，該項目還將保持現有 Gowanus 設施所展示的關鍵基礎設施復原能力。

公共信息會議將提供有關項目和第 10 條審查過程的信息，並將為公眾提供提問的機會。
