Administration

- Review/Modify Agenda: The Draft Agenda was adopted without modification.
- The Draft Minutes from the 3/20/2015 EDI Business Working Group (BWG)/Technical Working Group (TWG) meeting were adopted as Final with modification to the attendance list.

Regulatory Update Regarding EDI Matters

The BWG Chair noted that an initial draft of the report was posted on the April 7 EDI Report webpage. A more complete draft will be posted Monday 3/30 and will also be circulated via email. Comments on that draft should be sent to the BWG Chair via email by close of business on Thursday 4/2.

Modifications to PSC EDI Web pages

The link to National Fuel's EDI web page from Utility EDI Guides web page is now operational. The initial version of National Fuel's Utility Maintained EDI Guide is a work-in-progress; essentially much of the content is being relocated from the current web page into the guide. Other utilities should send an email containing a link for their web pages/guides to Robin Taylor (Staff) when their guides are ready; NYSEG/RG&E noted they had begun work on their guide. The TWG Chair asked if other utilities had begun work on their guides. The BWG Chair noted that guides should be available before testing in September to help make ESCOs aware of the changes that need to be implemented by November 2nd.

ESCO Assistance Program Participant Credits

The BWG Chair recapped his discussion with Staff concerning billing window issues and provision of credits when customers no longer receive bills prepared by utilities. Staff understands that there will be certain cases where ESCO will have to issue the credits directly to customers, e.g. if the customer has moved out of a utility's service territory. Staff's preference is to maximize the number of APP Credits provided through utility issued bills. Staff further understands that the EDI Working Group will continue to work on solutions to these issues, which may vary by utility and include non-EDI alternatives, and on development of other transactions related to the APP Credit.

Review of Updates to EDI Standards Documents

The EDI Working Group reviewed workpapers prepared by O&R, NYSEG/RG&E & National Fuel the addressed various inconsistencies, errata and/or clarifications impacting the EDI Standards documents for the 814C, 814D and 814E transactions. Additionally, changes to the 814C Business Process document reflecting discussion form the 3/20 EDI Working Group meeting were reviewed.
