NOTICE OF SECOND TECHNICAL CONFERENCE  
AND REVISED COMMENT SCHEDULE

(Issued July 2, 2013)

On June 5, 2013, the Commission issued a Notice Soliciting Comments and of Technical Conference, which, in part, sought comments on the documents submitted by the Department of Public Service Staff (DPS Staff) on June 4, 2013. These documents included a DPS Staff Straw Proposal for Regulated Reliability Cost Allocation and Cost Recovery (Straw Proposal), and a Reimbursement Agreement proposed by the New York Power Authority for the recovery of costs incurred in connection with the Indian Point Reliability Contingency Plan. The June 5, 2013 Notice indicated that initial comments should be submitted by July 8, 2013, while any reply comments thereto should be submitted by July 22, 2013. In response to requests from parties at the first technical conference on June 21, 2013, this notice is to advise interested parties that initial comments should be submitted by July 22, 2013, and reply comments should be submitted by August 5, 2013.
