

**TO ALL LANDOWNERS OF LAND ON WHICH ANY PORTION OF THE FACILITY PROPOSED IN CENTRAL HUDSON GAS & ELECTRIC CORPORATION'S PUBLIC SERVICE LAW ARTICLE VII APPLICATION TO THE PUBLIC SERVICE COMMISSION IS TO BE LOCATED:**

Central Hudson Gas & Electric Corporation intends to file an application (the "Application") on or about December 29, 2017 with the New York Public Service Commission (the "Commission") pursuant to Public Service Law Article VII requesting a Certificate of Environmental Compatibility and Public Need to rebuild the existing 69 kilovolt (kV) H and SB transmission lines (H and SB Lines) located between Kingston in Ulster County and Catskill in Greene County, New York (the "Project") to 115 kV requirements.

The scope of the Project as proposed is to remove and replace all structures, insulators, electrical conductors associated with the existing H and SB 23.6-mile long Right-of-Way (ROW) with the exception of 24 structures that will be retained. These 24 retained structures include those which must be or were replaced on an emergency basis prior to commencement of construction of the Project or are otherwise deemed to be structurally sound and will not need to be replaced as part of the Project. There are currently 256 existing transmission structures within the H and SB Lines ROW, which will be replaced with 229 new/replacement structures. The new line will have 253 structures in total. Generally, the proposed new construction will consist of single-pole Corten (self-weathering) steel structures of the same height or slightly taller than the current lattice towers, and with a smaller footprint. The structure heights will vary depending on terrain, but on average will be 77 feet above the ground and approximately 13 feet directly embedded in the ground, although for certain locations engineered structures may be required (i.e., concrete foundations).

Approximately 1.2 miles of the existing H Line route is proposed to be relocated to avoid a sensitive environmental resource area designated by the New York State Department of Environmental Conservation as the Great Vly Wildlife Management Area.

The proposed route of the Project will traverse a small portion of the City of Kingston, and portions of the Towns of Ulster and Saugerties within Ulster County, and the Village and Town of Catskill within Greene County.

Your property may be impacted by this Project.

After the Application has been filed and the Commission has started the Article VII case, interested persons who wish to participate as parties in the case may file for party status. This may be done through the Commission's web site. From the home page of the Commission's web site (<http://www.dps.ny.gov>), a prospective party should click on "Search." Under "Popular Searches" select "Latest Cases/Matters started". In the "Search" section of the web page that appears, enter "Central Hudson" in the "Keyword Search" box, then press "Search" on the right side of the page. Then, in the "Search Results" at the bottom of the page, click on the Case/Matter number on the left side. This will bring the user to the main Document and Matter Management ("DMM") page for this case. On that page, the prospective party should click the button at the upper right labeled "Request for Party Status" to see a web page with instructions for the procedures to follow to become a party. The timeframe for filing a request to be a party to this case is throughout the pendency of the case.
