Dear Hon. Burgess:

Please accept this letter as notification of the change in name of ACN Communication Services, Inc. ("ACN" or "Company") to ACN Communication Services, LLC. ACN is authorized to operate as a provider of telecommunication services within the state of New York pursuant to a Certificate of Public Convenience and Necessity granted in Case No. 00-C-0138.

ACN Communication Services, Inc., a Michigan corporation, underwent a statutory conversion to become ACN Communication Services, LLC, a Michigan limited liability company. The conversion of the Company to a limited liability company was merely a change in its corporate form accomplished through the filing of a Certificate of Conversion in Michigan and did not entail any merger or other transactions interrupting the existence of the Company.

The change in corporate form will have no customer impact, as the name reflected in all customer communications (bills, notices, customer service, etc.) will remain "ACN Communication Services." Therefore, customer notice was not required. However, a bill message notice was provided to customers stating: "'ACN Communication Services, Inc.' has converted to a limited liability company and its name is now 'ACN Communication Services, LLC'. This change will be processed by the appropriate authority(ies) in your state, but it will not affect your service or rates, including any of your rights or obligations."

Attached as Exhibit A is the Company's authority to transact business in New York issued by the New York Secretary of State.

Attached as Exhibit B are the Adoption Supplements for New York PSC No. 2 (Local) and New York PSC No. 3 (Access) reflecting the change in Company name with an effective date of May 9, 2017.
