### **AGREEMENT**

This Agreement, effective as of this 29th day of April 2014, or on the date when signed by the party signing last in time, made and entered into, by and between National Grid USA Service Company, Inc., for and on behalf of its affiliate company New England Power Company, both corporations organized and existing under the laws of the Commonwealth of Massachusetts, with a principal place of business at 40 Sylvan Road, Waltham, Massachusetts 02451 each d/b/a "National Grid" (hereinafter collectively the "COMPANIES" and individually the "Company") ("Owner"), and Allan Briteway Electrical Contractors, Inc. ("Contractor"), a corporation organized and existing under the laws of the State New Jersey, with its principal place of business at 130 Algonquin Parkway, Whippany, NJ 07981 (hereinafter each, individually, a "Party" and, collectively, the "Parties") for the Services identified hereafter as:

#### 2014 NEP TRANSMISSION TOWER PAINTING PROJECT

#### SAP Contract Nº 4400004273

#### ARTICLE 1 - SCOPE OF WORK

- 1.1 The Contractor hereby agrees to provide all materials, labor, and equipment to prepare, prime, coat, and clean up following delivery of services (the Work") to paint certain electric transmission line structures, all in accordance with this Agreement.
- 1.2 Work includes but is not limited to, furnishing all material and labor associated with traffic controls, staging areas, paint and primer, paint application related materials, inventory management, inventory security, site management, meetings, training, environmental and runoff controls, snow removal, environmental controls and site restoration, and any and all temporary features as needed for completing the Work as the site conditions encountered may warrant or change during the duration of the project.
- 1.3 The designated Work locations are as follows (See MAPS schedule B):

Double Circuit Line # M13/N12:

Towers # 1 – 9 located between Somerset and Sykes Rd

Towers # 38/1, 39-1, and 40-1 located between Canonicus and Dexter Street at the Sakonnet River

Double Circuit Line # M13/L14:

Towers # 11A - 18A, # 22A - 24A between Bell Rock Rd and Bates St Tap, near/at the crossings of Route 195 and Route 24

Towers# 19 - 21 between Bates St Tap and Canonicus

1.4 Owner reserves the option of adding to or deleting from the list of sites identified in ¶ 1.3.

- 1.5 Contractor is to physically inspect entire work right-of-ways and work sites prior to mobilization. Upon adequate notice from the Contractor, Owner will make arrangements for access improvements any and all matting.
- 1.6 The Contractor hereby agrees to perform the following Work under this Agreement, in accordance with the specifications provided in Article 2.
- 1.7 The Owner has categorized this Work as "High Risk." The Contractor assumes responsibility for the safe performance of the work and shall comply with all applicable safety requirements set forth in Article 2, Schedules A and E, including those for "Medium Risk" Work activities.
- 1.8 The Contractor may be required to perform additional work. Such out-of-scope work as outlined in the Agreement as 'unit priced items' will be executed by the Contractor as part of the job requirements, and shall be paid in accordance with Schedule D.
- 1.9 No other work shall proceed without authorization. Additional Work may be identified by Owner for which Contractor shall submit a proposal. Owner, at its sole discretion may authorize Contractor to perform said Work. All work shall be authorized only upon complete execution of a Work Authorization Form (WAF) or Field Change Form (samples included in Schedule C). Contractor shall commence performance of authorized Work immediately and in accordance with this agreement unless otherwise mutually agreed and documented.

#### **ARTICLE 2 - CONTRACT DOCUMENTS**

2.1 The following documents, including all attached schedules, appendices, exhibits or other attachments thereto, are incorporated by reference as if fully set forth herein, and are hereinafter referred to collectively and individually as the "Contract Documents" or the "Agreement" listed in order of precedence:

2.2 Contractor acknowledges and agrees that corporate information and query responses entered by the Contactor into the <a href="https://www.ISNetworld.com">www.ISNetworld.com</a> application are by reference made part of this Agreement.

2.3 Contractor acknowledges and agrees that corporate information, query responses, or policy affirmations as entered or periodically updated by the Contactor into the Owner's Communi-T Master Data Tool (CMDT) are by reference made part of this Agreement.

#### ARTICLE 3 - TERM

- 3.1 This Agreement shall be effective beginning on May 1, 2014, or when the Agreement is executed by all parties, whichever occurs last in time. It shall continue in full force and effect until December 31, 2014, or in accordance with the provision of Article 14 of the Terms and Conditions 0700.
- 3.2 Contractor's Work activities must be scheduled, managed, and completed by October 21, 2014. All submittals and payments must be completed by December 31, 2014, at which time the SAP Contract will be closed to transactions.

### ARTICLE 3 - SCHEDULE

- 4.1 Any Work to be performed under this Agreement shall be commenced in accordance with the schedule(s) developed by the Contractor and accepted by the Company's Project Manager for each individual Work Request associated with this Project. The Owner and Contractor will discuss at a pre-construction meeting the required modification of the proposed schedule (Schedule D-4). The Contractor shall prepare updated schedules as requested by the Project Manager(s).
- 4.2 Any supplemental Work, extra Work, or changed Work shall be conducted in accordance with Schedule A, § 33 and a schedule to be developed in association with a Work Authorization Form or Field Change Form (Schedule C).
- 4.3 The Contractor shall perform the Work in accordance with the schedule. Once commenced, the Work shall be prosecuted continuously to completion unless otherwise agreed to by the Company.
- 4.4 The Contractor shall maintain a labor force of sufficient size and competence to conform to and complete all Work on schedule and within the scheduled hours and days set forth in the schedule unless otherwise directed or approved by the Company.
- 4.5 Time is of the essence as to performance by the Contractor of its obligations under the Agreement. If, at any time during the term of the Agreement, except for delays occurring pursuant to Terms and Conditions for Contractor Purchase Orders Article 6, Force Majeure, in the opinion of the Company the Contractor does not meet the schedule, the Company may for each incident of delay, at no additional cost to the Company, at is sole option:
  - (a) Require the Contractor to get back on schedule by working additional shifts and/or additional days and/or increasing its manpower, supervision, tools, and/or equipment.

and/or

(b) Treat such failure as a material breach and repudiate and terminate the

Agreement and recover damages in accordance with Terms and Conditions for Contractor Purchase Orders Article 14.0, Termination.

#### ARTICLE 5 - CONTRACT PRICE

- 5.1 This is a Unit Price, plus Time and Expense Blanket Contract that is based on the Contractors' submittal dated April 30, 2014.
- 5.2 The Contract Price shall be the total price to be paid by the Owner to the Contractor in accordance with the prices set forth in the Unit Price Schedule, attached hereto as Schedule D-1, and any authorized and approved extra work as specified in the relevant Work Authorization Form in accordance with the Time and Expense rates set forth in Schedules D-2 and D-3.
- 5.3 Each unit price shall be all inclusive, unless otherwise stated, and shall include all work reasonably associated with or implied by the unit as applicable, including but not limited to, make ready work, temporary facilities, labor, materials (not specified as being supplied by Owner), services, equipment, documents, profit, taxes, insurance, and other overheads, and incidental and miscellaneous items necessary to perform the Work. Unless otherwise agreed to in writing by the Owner and Contractor each unit price shall remain applicable regardless of the final quantity of units used.
- 5.4 Unit prices as set forth in Schedule D-1 are fixed and firm for the term of the contract, as are the labor and equipment rates of Schedules D-2 and D-3. Fuel, lubricants and all maintenance shall be included in the equipment rates as set forth in Schedule D-3.
- 5.5 The Contractor shall, on a daily basis, furnish the Owner with daily work reports (in a format acceptable to the Owner) which briefly describe the Work rendered during the preceding day. Reports are to reflect the progress and description and number of any units completed. All quantities shall be verified by signature of the Owner's Field Representative. A duplicate of the original signed daily work report and receipts and invoices for Contractor-furnished materials, rented equipment and Subcontractors shall accompany all invoices which the Contractor shall present for payment.
- 5.6 The work of this scope is considered exempt Capital Improvement and is not taxable in Rhode Island.
- 5.7 The Contractor is responsible for all applicable taxes associated with the work scope. Taxes are not applicable to labor. No sums in addition to the original contract amount will be paid by the Owner for taxes, fees, permits, or other levies which may be imposed on the world by any authority having jurisdiction over the work of services to be provided and or performed by the Contractor.

#### ARTICLE 6 - PAYMENTS

6.1 Allan Briteway Electrical Contractor's National Grid Supplier Identification Number is 1000007151.

- 6.2 For all sums payable to the Contractor, as described in Article 5, National Grid will pay Contractor in accordance with Terms and Conditions § 8. Any allowable time for early payment discount shall begin the day the invoice is received at National Grid. The invoice date will not be used to calculate the allotted time available to exercise the specified payment discount. Unacceptable invoices may, at National Grid's option, be adjusted and paid as adjusted or returned to the Contractor for correction and resubmittal.
- 6.3 The Contractor shall submit one invoice upon Final Acceptance of the Work by the Owner. The invoice shall be submitted and payment made in accordance with and subject to the terms and conditions set forth in the Terms and Conditions. Failure by the Contractor to submit complete and timely invoices may adversely affect payment thereof by National Grid.
- 6.4 All invoices for scheduled Work shall be submitted and payments made in accordance with and subject to the Terms and Conditions. The invoice shall reference the Purchase Order Number, the name of the Owner's Field Representative who supervised the Work, and any Work Order number identified by the Owner's Field Representative.

- 6.5 Invoicing will be authorized for payment using National Grid's SAP enterprise system. The Contractor shall follow instructions for using this system as may be issued by the Owner following system updates.
- 6.6 <u>Diversity Target Invoice Reporting.</u> It is understood that National Grid has established a goal of not less than 10% of the total contract value to be subcontracted to a certified Minority or Women-owned Business Enterprise (Diverse Supplier). As a National Grid Contractor, your firm is required to quarterly report such 2nd Tier Diversity Spend as directed in separate post-award communications.

- 7.3 Contractor is to advise Owner of any substantive corporate changes that could affect administration, data records or payments. Changes, such as phone numbers, legal address, 'remit to' address, ACH/banking, TIN, etc. are to be reported to Owner's Communi-T Master Data Tool (CMDT) using Contactor's password. CMDT instructions will be communicated separately. Failure to make updates could delay payments.

### ARTICLE 8 - SEVERAL LIABILITY

Notwithstanding Schedule A § 22 and § 23, the rights and obligations of each National Grid company in connection herewith shall be several and not joint.

#### **ARTICLE 9 - ENTIRE AGREEMENT**

This Agreement, including all Contract Documents, constitutes the entire Agreement between the Owner and the Contractor, with respect to the Work specified, and all previous representations relative thereto, either written or oral are hereby annulled and superseded. No modification of any of the provisions of this Agreement shall be binding unless in writing and signed by a duly authorized representative of each party hereto.




