
Staff will be contacting you in the next few days to schedule a meeting at the earliest convenience of the project team. During that meeting staff will review the

During the meeting Staff will also discuss development of a detailed implementation plan, including a detailed schedule, budget, projected milestones and appropriate metrics. The implementation plan is expected to evolve and incorporate lessons learned or new developments within the scope of the project. The project implementation plan will be updated quarterly and will include the reporting obligations set forth in the above referenced Order. Once developed, the implementation plan and updates for will be filed with the Secretary of the Commission.
