Charter Communications, Inc. Network Expansion Plan Update and Communications Plan Compliance Filing

Charter Communications, Inc. ("Charter" or the "Company") respectfully submits this Network Expansion Plan Update ("Update") to provide the Public Service Commission ("Commission") with revised information regarding its Network Expansion Implementation Plan ("Plan").¹ This submission also serves as Charter's Communications Plan Compliance Filing ("Compliance Filing").²

BACKGROUND

On July 5, 2016, Charter submitted the Plan³ regarding the implementation of Ordering Clause B.1 of the Merger Order.⁴ On July 26, 2016, Charter filed a Revised Plan to present additional locational information regarding the network expansion plan.⁵ In accordance with the opportunity to file quarterly updates to the Plan "as necessary," on November 18, 2016, an additional update to the Plan was submitted and this further Update is being filed to explain additional changes to Year One of the Plan.⁷

On June 19, 2017, the New York State Department of Public Service ("Department" or the "Staff"), the Commission, and Charter entered into a Settlement Agreement (the "Settlement Agreement") in anticipation of Charter completing less than 25% of the required extension of its network to pass an additional 145,000 unserved and/or underserved units of businesses (36,250) by May 18, 2017 under the Merger Order.⁸ The Settlement Agreement directed Charter to

prepare and implement a Communications Plan to assist residents and businesses in identifying if and when they can expect passings to occur in their locations.⁹

SUMMARY OF THE UPDATE AND COMPLETED WORK

Details of this Update, including location and geospatial information of each passing, are included in the following Exhibits:

- Confidential **Exhibit A** Bulk Address List¹⁰
- Confidential **Exhibit B** Explanation of Plan Adjustments

In sum, the total of confirmed, qualifying passings under the Plan to date is 21,179.

Major areas of completed passings since May 1, 2017 include, but are not limited to, the following:

- Erie County for approximately 150 passings, including areas such as the Cities of Buffalo and Tonawanda and the Towns of Amherst, Cheektowaga, Derby, Grand Island, Lancaster.
- Jefferson County for approximately 214 passings, including the Towns of Clayton and Watertown and the Villages of Mannsville and Theresa.
- Monroe County for approximately 444 passings, including areas such as the City
 of Rochester, the Towns of West Henrietta, Pittsford, Penfield, Webster, and the
 Villages of Brockport and Fairport.
- New York County for approximately 594 passings, including the City of New York and the Boroughs of Manhattan and Staten Island.
- Niagara County for approximately 113 passings, including the Cites of Lockport, Niagara Falls, and North Tonawanda.
- Orange County for approximately 172 passings, including areas such as the Towns of Goshen, and New Windsor, and the City of Middletown.
- Oswego County for approximately 94 passings, including the Village of Cleveland.
- Rensselaer County for approximately 164 passings, including the Towns of Grafton, Sand Lake, and Schodack, the Villages of Castleton-on-Hudson and Schaghticoke, and the Cities of Rensselaer and Troy.

- Saratoga County for approximately 221 passings, including the Towns of Malta, Milton, Northumberland, Stillwater, Clifton Park, Ballston Lake, Halfmoon, and Wilton and the City of Saratoga Springs.
- Steuben County for approximately 86 passings, including areas such as the City of Corning and the Villages of Painted Post and Hammondsport.
- Sullivan County for approximately 209 passings, including the Towns of Fallsburg, Liberty, Victor, and Thompson, the Hamlet of Ferndale, and the Villages of Monticello and Woodridge.
- Tompkins County for approximately 112 passings, including the City of Ithaca, the Towns of Dryden and Newfield, and the Village of Groton.
- Ulster County for approximately 175 passings, including the Towns of Rochester, Ulster, Saugerties, and Wawarsing and the City of Kingston.
- Westchester County for approximately 168 passings, including the City of Mount Vernon.

COMMUNICATIONS PLAN COMPLIANCE FILING

Paragraph 18 of the Settlement Agreement required that Charter provide an excel spreadsheet which contains address level data for each passing for each twelve-month period of the Agreement. These addresses plus the passings completed to date under the Plan must total 145,000 passings to unserved and underserved premises. Attached Confidential Exhibit A identifies 145,000 total passings completed or planned, and it also fulfills the requirement in the Settlement Agreement that Charter provide the Commission and the BPO a bulk address list. This data will be updated every six months based on deployment changes made from time to time by Charter.

Also in accordance with Paragraph 18(c) of the Settlement Agreement, a public information portal will be available on Charter's website as of the date of this filing. This portal is an interactive website for the use of residents and businesses to obtain information related to their individual properties or tenancies at a street address level along with specific tentatively

planned completion dates. The website data will be revised as changes to the Plan are updated

every six months.

The portal website is accessible at http://www.bldlkup.com/, which can be referenced by

the Commission and the BPO on their websites. Moreover, in accordance with Paragraph 18(h)

of the Settlement Agreement, meetings were recently held between Charter and Staff to discuss

the communications plan including the website and a call center script, which was reviewed by

Staff pursuant to the Settlement Agreement on August 8, 2017.

CONCLUSION

Charter remains committed to the significant task of bringing broadband to 145,000

unserved or underserved homes and businesses in New York, as well as to compliance with the

Conditions of the Merger Order and the Settlement Agreement. Charter will continue to work

closely with the Commission to successfully implement the Network Expansion Plan as well as

with the BPO to assist the State in support of the NY Broadband program.
