## ERRATA NOTICE

(Issued July 3, 2008)

The Order Establishing Energy Efficiency Portfolio Standard and Approving Programs, issued June 23, 2008 in this proceeding (the Order) contained two errors in Table 18 on page 18 of Appendix 1. This Notice corrects the errors in Table 18 and a corresponding figure in Ordering Clause 3. As explained below, the figure in paragraph number 3 on pages 69-70 of the Order is hereby revised to read \$11,380,639, and allocations in Table 18 of Appendix 1 are hereby revised, as presented in the attached revised page 18 of Appendix 1.

On page 41, the Order authorizes gas utilities serving more than 14,000 customers to establish surcharges as set forth in Appendix 1. Table 18 in Appendix 1 did not set forth surcharges for Corning Natural Gas Corporation and St. Lawrence Gas Company, Inc., both of which serve more than 14,000 customers. Allocations in Table 18 are adjusted in the revised page 18 of Appendix 1 to reflect inclusion of these two companies.

The allocations in Table 18 reflect utility rebate programs that have already been approved. The figures in Table 18 understated the latest rebate programs of KeySpan Energy Delivery Long Island and KeySpan Energy Delivery New York by a total of \$1,836,575. Allocations are adjusted in the revised page 18 of Appendix 1 to reflect the actual figures for existing rebate programs of those two companies.

Ordering Clause 3 provided for annual gas revenue collections of \$13,190,693. This figure is adjusted, as described above, to reflect the correct total of existing rebate programs. The resulting figure, \$11,380,639, is allocated across the gas utilities specified on page 41 of the Order, producing the results included in the attached revised page 18 of Appendix 1. Finally, it should be noted that the allocations are applicable only to firm service.
