On July 10, 2009, United Water filed a request for approval of its first surcharge to recover the costs incurred to date for the progress in its efforts to build a long term water supply project as required by the Commission's Order in the above-referenced case.

In its July 10th filing, UWNY indicated that it intended that the surcharge would become effective on August 26, 2009 in accordance with the approval time period specified in the Joint Proposal.
