## **EOP Objectives**

If the severity of a weather event or emergency warrants, dry ice and/or bottled water may be provided in storm-damaged areas.

#### Storm Event

Instructions: Description of storm objectives to be completed. Indicate "Not Applicable" if this section is not applicable for the EOP subject matter.

If service interruptions are expected to last more than 48 hours, the Incident Commander (IC) will assess the need for implementation of a **Dry Ice and/or Bottled Water Program**. Under the direction of the **Logistics Section Chief**, a **Dry Ice Coordinator** follows the general procedure given below:

- Estimate the number of customers who will be without electricity when dry ice and/or bottled water is distributed
- Coordinate the location of distribution centers
- Arrange for distribution of dry ice and/or bottled water at each distribution center
- Consult with the Public Information Officer (PIO) for communication of distribution times and locations to the Incident Commander (IC), Customer Relations Center (CRC), Web Coordinator and the PSC.



- Provide safety information to customers regarding the use and handling of dry ice
- Monitor status of outage, to estimate dry ice and/or bottled water procurement and distribution
- Submit dry ice/bottled water information reports to the Area Command
   Planning Section (ACPS) Chief as needed for email updates to the PSC (usually 7 am, 11 am, 3pm and 7pm)

Information regarding the location and operating hours of distribution centers will be available in news releases, via the Outage Central web page, on the IVR upfront recordings and through CRC representatives taking customer calls.
