Please accept this correspondence as an update in Staff's prudence case in the above referenced matter. Since the last update, Staff received the final report from CRA which it then forwarded to Con Edison. As noted in the last update, pursuant to the three party contract, Staff was required to provide the Company with a copy of the final report prior to making such report public to allow for Company comment. We received the Company's comments on Monday 10/4 and are reviewing them, anticipating that we will soon file the report with the Secretary in the Investigative Accounting Examination, case #09-M-0243. In addition, Staff is working with its contractor to develop a work plan and scope for phase 2.
