Administration

• Review/Modify Agenda: The Draft Agenda was deferred to a new meeting date on 4/13/2018 so discussion could be focused upon the cyber-attack situation at ESG.

Discussion

Gary Lawrence (ESG) provided a general overview of the situation but stated he was not prepared to field any questions. ESG has begun processing transactions but need to reestablish connectivity with each of their customers.

Lawrence noted that each utility has different requirements to be met before connectivity is restored; some companies are requesting Data Security Agreement and others are requiring different types of testing, etc.

DPS Staff observed that the cyber-attack has been an eye opening event and that currently, utilities typically do not have a contractual relationship with the EDI Service Providers that serve ESCOs. Staff encouraged EDI Service Providers to sign Data Protection Agreements or risk assessments that may be required by each utility.

In response to questions from ESCOs, utilities described the degree to which their operations were impacted by the cyber-attack. In some cases, EDI transactions were still being exchanged on a business as usual basis while in other cases, transactions were halted. Billing windows were being held open in some cases where utilities support bill ready consolidated billing. ESCOs were encouraged to review/verify their transactions when connectivity is fully restored because no one can be sure of what has or hasn't been sent.
