
Turkey season is open, 13-year old gets his first gobbler

sions are being done at the right depth, as well as if they are being done too fast or slow.

"We will also have the ability to download the information in the AED to a computer so we can go back and analyze it later," Ladd said.

Having these AEDs will

give Chaffee-Sardinia an edge on response time. If the company is on standby, and a first-aid call comes in, the call can be answered without an ambulance because of the AEDs. Getting to calls and administering CPR as quickly as possible is extremely important. Members of the department

know that if CPR is not administered within the first 10 minutes, chances of survival decrease by half.

The price of the defibrillators is about \$1,250 each, but Sean Schafer, who is an EMS Lieutenant for Chaffee-Sardinia, realizes the importance of having this kind of equipment.

"I know this seems expensive, but if we can save more lives, you can't put a price on that," Schafer said.

Schafer and the other members of the department know that purchases like these would not take place without the support of the people in the community. Ladd says that events like the annual carnival are extremely important, and board member Troy Heineman agrees.

"The carnival, along with the pizza wagon at the Strawberry Field's tractor pull and the tool raffle help us to help the community."

The Chaffee-Sardinia Fire Department would like to thank the people in their community for all of the financial help they've given them through the years. Schafer sums it up by saying, "In the long run, all of the financial support is helping us to save more lives."


