Effective Date of Major Rate Change and  
Initiation of a Proceeding

**TO:** Long Island Water Corporation, d/b/a Long Island American Water

**FROM:** Secretary to the Commission

**SUBJECT:** Case 11-W-0200 – Proceeding on Motion of the Commission as to the Rates, Charges, Rules and Regulations for Long Island Water Corporation, d/b/a Long Island American Water.

**RECOMMENDATION:** Initial Suspension of the Effective Date of Major Rate Changes Proposed by Long Island Water Corporation, d/b/a Long Island American Water and Initiation of a Proceeding.

On April 29, 2011, Long Island Water Corporation, d/b/a Long Island American Water (LIAW or the Company) filed amendments to its tariff schedule, P.S.C. No. 1 – Water, which would produce an annual base rate increase of about \$9,563,146 or 19.49% for the rate year ending March 31, 2013.

The Company's filing, which has an effective date of May 31, 2011, constitutes a major rate increase and requires that the filing be suspended and that hearings be held. Without answer or other formal pleading, a proceeding is instituted concerning the propriety of the rates, charges, rules, and regulations contained in the tariff amendments to P.S.C. No. 1 – Water, listed in the Appendix to this Notice.

Pending the proceeding and decision on the proposed changes, the operation of the proposed amendments is suspended and the use of the rates, charges, rules, and regulations

contained in the proposed amendments is deferred through September 27, 2011, unless otherwise ordered by the Commission.

The rates, charges, rules, and regulations altered by the suspended amendments shall continue in effect until this proceeding is concluded or until the period of initial suspension and any extended suspension expires, unless otherwise ordered by the Commission.

Long Island Water Corporation, d/b/a Long Island American Water is directed to file with this Commission not later than May 26, 2011, a consecutively numbered supplement announcing suspension of the amendments listed in the attached Appendix.
