8. CONFLICTS OF INTEREST

Neither Overland nor its subcontractors have provided services directly to any New York utilities or their affiliates within the past five years. However, both Overland and its subcontractors have been hired by state regulatory commissions to perform audit or other consulting services related to New York utilities and/or their affiliates.

In August 2016, Overland and its subcontractors were contracted by the New York State Public Service Commission to perform a comprehensive management and operations audit of Central Hudson Gas & Electric Corporation. This management audit is ongoing.

His roles included work for National Grid's operating companies in New York, including KEDLI, KEDNE, and NMPC. His NY Transco work involved several interactions with DPS staff.

From 2012 to 2013, Donald Racey, while working for a professional consulting firm prior to FTI Consulting, was engaged by National Grid USA to support the creation of an electric and gas project management playbook that was directly used by National Grid's NY Gas and Electric Companies.
