## **AGREEMENT**

This Agreement, made and entered into on the date when signed by the Party signing last in time, by and between Massachusetts Electric Company, Nantucket Electric Company, New England Power Company, and National Grid USA Service Company, Inc., Massachusetts corporations, with offices at 40 Sylvan Drive, Waltham, Massachusetts; The Narragansett Electric Company, a Rhode Island corporation, with offices at 280 Melrose Street, Providence, Rhode Island 02901; Niagara Mohawk Power Corporation, a New York corporation, with offices at 300 Erie Boulevard West, Syracuse, NY 13202; each a National Grid company (each a "Company"), and Nelson Tree Service, Inc., a corporation, having its principal place of business at 3300 Office Park Drive, Dayton OH 45439 (each a Party and collectively the Parties), for the Work identified as:

### **WITNESSETH:**

**WHEREAS**, the parties agree to amend the terms and conditions of the Agreement previously entered into by the parties on March 26, 2012 that was established to provide vegetation management services on the Company's distribution electrical systems in various locations within the Contractor's assigned Area of Responsibility and,

**NOW, THEREFORE**, in consideration of the terms & conditions previously agreed to and additional considerations incorporated herein, the parties agree that the Contract and Purchase Order shall be amended as follows:

## **ARTICLE 2 - CONTRACT DOCUMENTS**

The following documents, including all schedules, appendices, exhibits or other attachments to such documents, are incorporated by reference as if fully set forth herein, and are hereinafter referred to collectively as the Agreement and individually as "Contract Documents" or the "Agreement":

1. Schedule B, Price Schedules

Nelson VM-14 Award & FY15 Pricing

The provisions of this Agreement are intended to be complementary and consistent. If, however, there is any conflict or discrepancy between among the documents that comprise the Contract Documents, the order of precedence for resolving such conflict or discrepancy will be the sequential order of the documents in as listed above ("Order of Precedence"). If the Order of Precedence does not resolve any such conflict or discrepancy, the Engineer's determination of such conflict or discrepancy shall be final and conclusive. Capitalized terms in the Contract Documents are defined in the attached Terms and Conditions unless specified otherwise.

## **ARTICLE 6 - CONTRACT PRICE**

The Company will pay the Contractor for the segment of spend as stated in this amendment of Schedule B "Nelson VM-14 Award & FY15 Pricing" attached hereto.

Pricing on the Schedule B reflects the work awarded for the third year of this contract.

The Contract Price shall be adjusted for additions, deletions or changes to the Work as set forth in Section 10.1 of the Terms and Conditions and as revised below. Acceptance of this change order will firm pricing for the 2015 fiscal year (April 1, 2014 through March 31, 2015).

**CHANGE ORDER PROVISIONS:**


All other terms and conditions of the original agreement and all amendments thereto remain unchanged.
