This is to inform you that Cape Vincent Wind Power, LLC (CVWP) has submitted a Preliminary Scoping Statement to the New York State Board on Electric Generation Siting and the Environment (Siting Board) regarding CVWP's proposal to construct and operate a 200-285 megawatt wind energy facility in the Towns of Cape Vincent and Lyme and the Village of Chaumont, Jefferson County. That filing triggers the need to appoint ad hoc public members to the Siting Board to participate in the review of the proposed facility.


Pursuant to Article 10 of the Public Service Law, in your capacity as President Pro Tem of the Senate, you should be receiving nominations of four candidates each for ad hoc public member from the County of Jefferson, Town of Cape Vincent, Town of Lyme and Village of Chaumont. You have 30 days from receipt of the list of nominated candidates to appoint one ad hoc member

from the list of candidates. If you do not make an appointment within 30 days, the Governor shall appoint the ad hoc member from the list of nominated candidates. If an ad hoc member has not been appointed within 45 days, a majority of persons named to the Siting Board shall constitute a quorum.

I would appreciate it if you would inform me of whom you have appointed to serve from the list of candidates as soon as you have made your decision.
