To the Parties:

We are in receipt of Deborah Kopald's October 18, 2018 application pursuant to 16 NYCRR Rule 3.4 for issuance of a subpoena duces tecum to Aclara Meters, LLC, Acara Smart Grid Solutions, LLC, and Aclara Technologies, LLC. We are treating this application as governed by the rules for motion practice, 16 NYCRR 3.6. Parties who wish to respond to the motion shall do so within eight days from service of the application, or by no later than Friday, October 26, 2018.
