Dear Mr. Novak,

I received your correspondence, dated April 30, 2015, on behalf of the New York Electronic Data Interchange ("EDI") Working Group ("EDI Working Group"), an ad hoc working group consisting of personnel from Utilities, Energy Service Companies and EDI Service Providers pursuing development of EDI Standards, requesting an extension until July 20, 2015 for submission of a report required by the *Order Approving Modifications to the Electronic Data Interchange Standards*, issued March 2, 2015 ("Order"), in the above referenced proceedings.

In support of your request for an extension, you stated that the EDI Working Group has had discussions. However, Department of Public Service Staff has not reviewed a Phase I testing proposal, which will be the basis for related streamlining proposals and EDI Standards modifications. Further, the EDI Working Group intends to develop additional EDI transactions to support the Assistance Program Participant (APP) Credit process. You state that the additional time will allow the EDI Working Group to submit a more comprehensive report, and to consider modifications to EDI Standards discussed in collaborative meetings regarding APP.

Dear Secretary Burgess:

On behalf of the New York Electronic Data Interchange ("EDI") Working Group ("EDI Working Group"), an ad hoc working group consisting of personnel from Utilities, Energy Service Companies and EDI Service Providers pursuing development of EDI Standards, National Fuel Gas Distribution Corporation hereby submits a request to extend the deadline for submission of a report required by the Order Approving Modifications to the Electronic Data Interchange Standards issued on March 2, 2015 ("Order") in the above referenced cases. The report identifies how EDI development, implementation and testing process¹ could be streamlined.

While the EDI Working Group has initiated discussions, DPS Staff has not had an opportunity to fully review a Phase I testing proposal upon which related streamlining proposals and EDI Standards modifications would depend. Additionally, the EDI Working Group plans to develop additional EDI transactions to support the Assistance Program Participant ("APP") Credit process. After consultation with DPS Staff and discussion during the EDI Working Group's April 24, 2015 meeting, an extension of the report due date to July 20, 2015 is requested. In addition to provision of a more comprehensive report, the Working Group will be in a position to consider modifications to EDI Standards reflecting the discourse of collaborative meetings addressing APP matters.²
