NOTICE ANNOUNCING TECHNICAL CONFERENCES

(Issued May 21, 2018)

PLEASE TAKE NOTICE that the New York State Department of Public Service (DPS) and the New York State Energy Research and Development Authority (NYSERDA) will jointly convene two technical conferences to take place on June 18, 2018 in New York City and June 29, 2018 in Albany.

The purpose of these technical conferences is for DPS and NYSERDA staff to present and discuss *New Efficiency: New York*, the white paper that defines the 2025 statewide energy efficiency target and sets forth strategies for achieving the State's new energy efficiency target.<sup>1</sup> Both technical conferences will include the same presentations and follow the same agenda, which is provided below, and includes several opportunities for stakeholders to ask questions regarding the contents of the white paper. The June 18<sup>th</sup> technical conference will take place in the 4<sup>th</sup> Floor Board Room of the DPS office located at 90 Church Street, New York, NY (NYC office) with video conferencing available in the 19<sup>th</sup> Floor Board Room of the DPS office located at Three Empire State Plaza, Albany, NY (Albany office) and in
