APPLICATION OF CONJUNCTION, LLC FOR A CERTIFICATE OF ENVIRONMENTAL COMPATIBILITY AND PUBLIC NEED PURSUANT TO ARTICLE VII OF THE PUBLIC SERVICE LAW FOR THE EMPIRE CONNECTION PROJECT

PETITION FOR INTERVENTION

The Town of Woodbury ("Woodbury") hereby petitions the Public Service Commission pursuant to N.Y. Public Service Law §124 (1)(i) and 16 NYCRR 016785.2.11(a)(6) to intervene as a party in the captioned certification proceeding.

Woodbury has an interest in the proceeding, as the proposed transmission line will be located within a critical transportation corridor, which runs through the middle of Woodbury. Disruption of the traffic pattern on the New York State Thruway would create an avoidable traffic problem for Woodbury in that the nearest North/South artery runs right through the middle of Woodbury, to wit, State Route 32, which is a two-lane road, which under the best of circumstances is already under considerable stress. Any disruption of the traffic pattern on the New York State Thruway as a result of this project is capable of creating virtual gridlock conditions in Woodbury, particularly if traffic patterns are in any way affected on weekends.

As the documents which have been made available to Woodbury to date are not clear as to whether the transmission lines are to be above or below ground, the visual impact and environmental impacts are not clear at this time. Wherever transmission lines are visible, they clearly will impact on a adjoining landowners and Woodbury has an interest in trying to protect the esthetic appearance of the town as well as any potential environmental impacts this project may ultimately create.

Lastly, as the overall scope of the project is not completely clear, it is expected that there may be additional interests which Woodbury would seek to have input and having active party status would be the only way to properly monitor same and protect the overall interests of the Town.

For the reasons stated above, Woodbury has an interest in the proceedings and its participation would contribute to the appropriate planning and safeguards as may be necessitated during the environmental compatibility process.

Woodbury therefore respectfully requests that it be added to the active party list in this proceeding and that all papers be served upon the following:
